**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA ADOPTING  
A DECLARATION OF LANDMARK DESIGNATION OF THE PROPERTY LOCATED  
AT 701 W. HOLLY STREET, PASADENA, CALIFORNIA**

**WHEREAS**, the City Council has found that the residence at 701 W. Holly Street meets Criterion C, as set forth in Section 17.62.040.D.2 of the Pasadena Municipal Code; and

**WHEREAS**, the property at 701 W. Holly Street is significant because it embodies the distinctive characteristics of the French Norman architectural style and represents the work of locally significant architectural firm Postle & Postle; and

**WHEREAS**, the application for Landmark designation is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15308; and

**WHEREAS**, Steven Davison and John Palmero, the owners of the property, submitted the application for designation; and

**WHEREAS**, the City Council may designate a landmark and evidence such approval by adopting a declaration executed by the Mayor pursuant to Subsection 17.62.050.C of the Pasadena Municipal Code.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PASADENA  
RESOLVES AS FOLLOWS:** The attached declaration of landmark designation for the property at 701 W. Holly Street is hereby adopted.

**DECLARATION OF LANDMARK DESIGNATION FOR:**

**701 W. HOLLY STREET  
PASADENA, CALIFORNIA**

Pursuant to the provisions of Section 17.62.050 of the Pasadena Municipal Code, the City Council of the City of Pasadena by this declaration hereby designates as a landmark 701 W. Holly Street, as described in the City Council Agenda Report dated October 30, 2023, at certain real property described as:

**THAT PORTION OF LOT 1 OF OAK SIDE TRACT, IN THE CITY OF PASADENA, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP RECORDED IN BOOK 53, PAGE 51 OF MISCELLANEOUS RECORDS, IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY, TOGETHER WITH THAT PART OF THAT PORTION OF LINDA VISTA AVENUE NOW KNOWN AS HOLLY STREET, AS SHOWN ON SAID MAP VACATED BY ORDINANCE NO. 1474 OF SAID CITY OF PASADENA, DESCRIBED AS A WHOLE.**

Under Pasadena Municipal Code Section 17.62.090, all work affecting designated Landmarks, except ordinary maintenance and repair, such as but not limited to new construction and additions, exterior alterations, relocation, and demolition, is subject to review by the City of Pasadena.
