CEREMONIAL MATTERS	Mayor Gordo presented a proclamation declaring the month of April 2024 as Donate Life Month in the City of Pasadena and recognized the lives saved through organ donations. Allen Jolley, One Legacy Ambassador, accepted the proclamation on behalf of the organization and shared the story of his young daughter's organ donation.

Mayor Gordo presented a proclamation declaring April 11-17, 2024 as Black Maternal Health Week in the City of Pasadena, and reaffirmed the City's commitment to eliminate racial disparities in health outcomes. Stella Clingmon Simon, Maternal Child Health Program Manager, and Monette Clark, Black Infant Health Program Coordinator, thanked the Mayor and City Council for the recognition and accepted the proclamation on behalf of the City's Health Department, and spoke on the Department's initiatives to address this nationwide crisis.

Mayor Gordo presented a proclamation recognizing April 2024 as Sexual Assault Prevention and Awareness Month, and encouraged everyone to participate in Denim Day on April 24, 2024 by wearing jeans, as part of the international effort to communicate that there is never an invitation to rape. Vanessa Rodriguez, Vice Chair of the Commission on the Status of Women (CSW), and Leticia Lopez, CSW Staff, accepted the proclamation on behalf of the Commission, thanked the Council for the recognition, provided comments on the importance of addressing together the underlying issues of sexual assault as a community.

Councilmember Hampton thanked the proclamation recipients for their hard work and requested that City staff take into further consideration these public safety and public health initiatives during the upcoming budget consideration.

Mayor Gordo announced that the 710 Highway Ad Hoc Committee has been established and the meeting schedule has yet to be determined. He noted that the ad hoc committee members include himself, Vice Mayor Madison, Councilmember Hampton, and Councilmember Lyon.

(5) Direct the City Attorney to prepare an amendment to the Sewer Use Charge Ordinance (Ordinance) implementing the changes to the Sewer Use Fee rate structure and rates described in the agenda report.

City Clerk Jomsky opened the public hearing and reported that the public hearing notice was mailed to all residents on February 21, 2024. He also reported that 1 letter in support of the staff recommendation and 290 letters protesting the proposed sewer rate structure and rate adjustments, and/or expressing concerns regarding the financial impacts that the increase would have on residents, were received by the City Clerk's Office, distributed to the City Council, posted online, and made part of the public record.

Tony Olmos, Director of Public Works provided introductory remarks on the item, and introduced the consulting firm, Raftelis Financial Consultants, who assisted staff by preparing the proposed rate study. Director Olmos reported that the proposed increases are necessary due to expenditures exceeding revenues received from the current rates. Steve Gagnon, Raftelis Financial Consultant, presented a PowerPoint presentation on the comprehensive rate study; reported that the City has not raised sewer rates by more than CPI since 2007, noted that the sewer fund has a negative cash balance, and highlighted that capital improvement projects have been delayed in order to continue normal operations. Director Olmos reported on community outreach efforts and presented the combined impacts of the utility rate increases.

The following individuals spoke in opposition to the proposed sewer rate structure and rate adjustments, and/or expressed concerns regarding the financial impacts that the proposed increases would have on residents:

James Kim, Pasadena resident Chris Patton, Pasadena resident Janice Stimson, Pasadena resident Richard Longobard, Pasadena resident Adriana Lim, representing Mountain Park Townhouse Villas HOA Elsa Saenz, Pasadena resident Peggy Names, Pasadena resident Rose Malmberg, Pasadena resident Kwok-Yin Cheng, Pasadena resident Joan Longoboard, Pasadena resident

Councilmember Hampton emphasized that the proposed rate increase is extremely steep, agreed that the impacts would be difficult for residents, and advocated for more gradual rate increases spread over the years.

In response to Councilmember Masuda's inquiry regarding why rates had not increased since 2007, Director Olmos stated that although CPI was previously sustainable with the previous rate, due to recent inflation impacts, the proposed increase is needed to keep up with current costs. Director Olmos reported that without the rate increase, the City would be unable to maintain sewage systems in compliance with legal requirements, which could create liabilities for the City. City Manager Márquez added that deferred maintenance would be more costly than proper/regular maintenance. In response to Councilmember Masuda's inquiry regarding imposing fees on developers, Director Olmos stated that a sewer facility fee is charged to developers based on the designs of the project and number of fixtures being installed.

Councilmember Lyon expressed agreement with the proposed rates, noting that despite the steepness of the increase, they are still well below rates of adjacent cities. He advocated for future built-in mechanisms (i.e., if reserves drop below a certain percentage) to trigger conversations or rate studies for rate increases.

In response to Councilmember Rivas' and Councilmember Jones' inquiries regarding alternative scenarios to the proposed rate

increases, Director Olmos noted that any lesser rate increase would change the outcome of the capital reserves over the next 5 years. He stated that if the proposed rate increase was halved, revenues would remain insufficient and capital projects would be continually deferred over the next few years, until revenues stabilize.

Vice Mayor Madison noted that expenditures exceed revenues in the staff report and inquired what funds were utilized to cover the costs of these expenditures. Director Olmos stated that a balanced budget was maintained by not building certain capital projects. Vice Mayor Madison requested additional time to consider this issue, and asked that Pasadena Water and Power staff also be present when this matter is discussed in the future.

Discussion ensued regarding the adopted budget allocation for the Fiscal Year (FY) 2024 sewer fund, the lack of a formal reserve policy, options/impacts if the City determined to raise revenues below the staff recommendation, and the resulting impacts on operating costs, capital/building reserves, and the availability of funds for sewer-related CIP projects.

Kris Markarian, Deputy Director of Public Works, provided clarification on the identified CIP projects, the current appropriations, and what Council has adopted as part of the CIP budget process. She noted the 5-year CIP budget and project list is adopted each year, so the appropriations and projects change each year.

Vice Mayor Madison spoke on what appears to be a budget shortfall, questioned how staff made adjustments (specifically if City Council authorization was provided), and requested that City staff to bring back additional information and details to address these questions.

Discussion ensued regarding the movement of funds from the operational budget to the CIP budget, and the adopted FY 2024-28 CIP budget and projects presented by staff. The City Council directed City staff to provide a revised report on the capital improvement budget details, with consistent terminology, to assist the City Council in understanding how funds were utilized.

City Manager Márquez suggested that the public hearings on Sewer Use Rate Adjustment and Refuse Rate Adjustment be continued and moved to May 6, 2024 at 5:30 p.m.

MOTION: Following discussion, it was moved by Councilmember Hampton, seconded by Vice Mayor Madison, to continue the public hearing to May 6, 2024 at 5:30 p.m., with direction to City staff to return with the following: (1) additional information regarding all upcoming utility rate increases, (2) the three fund buckets of operational costs, capital improvement budget/investments, and reserve funds; and (3) include Pasadena Water & Power staff and Finance staff to be present at the next discussion, and for the staff report to include more comprehensive and detailed information. (<u>Motion unanimously approved</u>) (Absent: Councilmember Williams)

PUBLIC HEARING: APPROVAL OF RECOMMENDED REFUSE COLLECTION FEE INCREASES (Public Works Dept.)

**<u>Recommendation</u>**: It is recommended that the City Council continue the public hearing to April 15, 2024 at 5:30 p.m.

It was moved by Councilmember Hampton, seconded by Vice Mayor Madison, to continue the public hearing for the Refuse Collection Fee Increase to May 6, 2024 at 5:30 p.m. (Motion unanimously approved) (Absent: Councilmember Williams)
