CITY OF PASADENA City Council Minutes April 29, 2024 – 6:00 P.M. City Hall Council Chamber

SPECIAL JOINT MEETING

Mayor Gordo and President Kenne called the Special Joint meeting of the City Council and Pasadena Unified School District (PUSD) Board of Education (Board) to order at 6:06 p.m. The Pledge of Allegiance was led by President Kenne.

PRESENTATION FROM PASADENA UNIFIED SCHOOL DISTRICT ON SCHOOL SITE MAINTENANCE INCLUDING GARDENING LANDSCAPE INFORMATION

Manuel Carrasco, PUSD Director of Facilities, provided a presentation on the recent facility enhancements at PUSD properties made throughout the school district, specifically relating to gardening and curb appeal. He provided an overview of the School District's efforts to maximize their current infrastructure and address the needs of maintenance of their facilities and landscaping.

Councilmember Hampton expressed concerns that some parkways and curbsides appear to be overlooked in regard to proper maintenance, emphasizing areas of need near Cleveland Elementary and Washington Elementary.

In response to President Kenne's concerns regarding the use of turf fields in the City, Councilmember Williams reported that the Senate Bill (SB 676) regarding turf fields will be discussed at a future Municipal Services Committee meeting, noting that the School District should participate in that discussion since PUSD's facilities and staff may be impacted.

Councilmember Masuda thanked Director Carrasco, PUSD staff, and Amigos de los Rios, for their collaboration in beautifying the areas surrounding Willard Elementary.

City Clerk Jomsky reported that 1 letter advocating for traffic improvements around Washington Elementary and La Pintoresca Library was received by the City Clerk's Office, distributed to the City Council and PUSD Board of Education, posted online, and made part of the public record for this item.

The following individuals expressed concerns regarding the deferred maintenance at the Allendale Elementary campus and having Longfellow Elementary students temporarily utilize the campus under poorly maintained conditions:

Nina Chomsky, Linda Vista Annandale Association, spoke on the importance of maintaining closed school site properties to prevent degradation and impacts to adjacent neighborhoods.

Rene Gonzalez, residence not stated, requested that a feature be created on the PUSD website to allow the public to take a photo and report maintenance issues.

Councilmember Hampton suggested that since the City already has a Citizen Service Center (CSC) app, the public can report issues related to PUSD through the app so City staff can forward them to the School District, as an alternative to having the District develop an entirely new feature.

Following discussion, on order of the President and Mayor, and by consensus of the Board of Education and City Council, the information was received and filed.

UPDATE ON CAREER TECHNICAL EDUCATION AND APPRENTICESHIP PARTNERSHIPS

Mayor Gordo introduced and thanked Congresswoman Judy Chu for securing federal funding to support career pathway opportunities for people of all ages within the Pasadena community.

Congresswoman Chu announced that she was able to secure \$1.8 million dollars in direct federal funding to support two of the City's project proposals – the Pasadena Facility for Jobs Creation, Training, and Education and the Pasadena Water Treatment Project. She reported that the funding will help cover labor, material, and construction costs for both projects.

Phyllis Hallowell, Assistant to the City Manager, gave a presentation on the Career Technical Education Pilot program formalized through a partnership between Pasadena City College (PCC), PUSD, and the City of Pasadena. She reported that City staff will be touring a model Career Education Program in Kern County on Thursday, May 9, 2024.

Dr. Helen Hill, Interim Chief Academic Officer, and Dr. Kristina Turley, College and Career Pathways Coordinator, presented the School District's High School Career Technical Education Pathways program and reported on student outcomes.

Alton Wang, PCC College Board Chair, spoke on the importance of community partnerships to offer students with career development opportunities and pathways to long-term careers.

Dr. Jose Gomez, PCC Superintendent, and Dr. Laura Ramirez, Vice President of Instruction, provided an update on the Career Technical Education programs offered by PCC. Dr. Ramirez reported on the various grants that PCC has received to fund a number of apprenticeship opportunities, and noted that PCC is working closely with PUSD to increase dual enrollment curriculum opportunities.

The following individuals expressed concerns with the lack of allocated funding for special education and inclusivity of students with disabilities in the Career Education Technical programs offered by PCC.

Rene Gonzalez, residence not stated Marlene Benites, Pasadena resident Zella Knight, Pasadena resident Superintendent Blanco reported that special education students are a part of Pathways program at John Muir High School and that PUSD has an agreement with PCC for PAL students between the ages 18 and 22 who attend classes.

Councilmember Hampton advocated for students with disabilities to be actively included in discussions pertaining to career education.

Following discussion, on order of the President and Mayor, and by consensus, the information was received and filed.

PRESENTATION REGARDING POTENTIAL AFFORDABLE HOUSING FOR PASADENA UNIFIED SCHOOL DISTRICT FACULTY AND STAFF, INCLUDING A DISCUSSION OF AB2295 AND SB35

Kingsley Udo, PUSD Interim Chief Business Officer, provided introductory comments on the item, and PUSD Facilities Director Carrasco gave an overview of PUSD's efforts to identify affordable housing resources for faculty and staff. He stated that PUSD will be working closely with Education Housing Partners on preliminary due diligence, and reported that next steps include presenting options to the School Board for review, followed by submittal of an application to the City for approval.

Jennifer Paige, Director of Planning, provided a presentation on Assembly Bill 2295 and Senate Bill 35, and responded to guestions.

Discussion ensued regarding income thresholds for the potential affordable housing units, the constraints on the use of proceeds, allowable land uses available to PUSD for use of its properties, and the Surplus Land Act.

Mayor Gordo expressed concerns that repurposing school site properties that are not being used in a permanent manner would prevent such properties from returning to educational purposes. He noted that PUSD, the City, the Board of Education, and the City Council have a collective responsibility of ensuring the success of public education in Pasadena.

Board Member Velasquez stated that the decline in student enrollment and local population reflects the need for community partnership, and emphasized the importance of supporting those who are disproportionately impacted in order to strengthen the K-12 system. In response to questions regarding options for use of affordable housing, Board Member Richardson Bailey expressed concerns that expanding the proposed project to include housing for members of the public that work in the community may create inconsistencies with the original intent of the housing project, which is to recruit and retain PUSD employees by providing affordable housing options.

Caitlin Mahaffey, residence not stated, urged the City and School District to allow for flexibility as part of the proposed project, and urged for careful decision-making to ensure that immediate housing needs do not impact educational needs of students.

Deirdre Duncan, Pasadena resident, expressed concerns pertaining to the availability of the affordable housing units in the City and urged for accountability.

City Clerk Jomsky reported that 4 letters, in support of the affordable staff housing initiative at the Roosevelt site, supporting a second site for student family housing, and/or providing comments on this matter, were received by the City Clerk's office, distributed to the City Council and PUSD Board of Education, posted online, and made part of the public record for this item.

Following discussion, on order of the President and Mayor, and by consensus the Board of Education and City Council, the information was received and filed.
