AUTHORIZATION TO ENTER INTO A CONTRACT WITH EIDIM GROUP INC., (dba EIDIM AV TECHNOLOGY) TO UPGRADE AUDIOVISUAL TECHNOLOGY IN THE COUNCIL CHAMBER IN AN AMOUNT NOT-TO-EXCEED \$275,136 (DoIT)

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed contract in the agenda report is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3), the "Common Sense" exemption that CEQA only applies to projects that may have an effect on the environment; and
- (2) Authorize the City Manager to enter into a contract, as a result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, with EIDIM Group Inc., to upgrade audiovisual technology in the Council Chamber in an amount not-to-exceed \$275,136, which includes the base contract amount and a fifteen percent contingency. Competitive Bidding is not required pursuant to the City Charter Section 1002(F), contracts for professional or unique services. (Contract No. 32700)

FINANCE COMMITTEE: AMEND THE POLICE DEPARTMENT'S FISCAL YEAR 2024 OPERATING BUDGET BY RECOGNIZING REVENUE AND APPROPRIATING \$43,334 IN GRANT FUNDS FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM (Police Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find that the project proposed in the agenda report is exempt under the California Environmental Quality Act (CEQA) Guidelines Section 15061(b)(3), the "Common Sense" exemption that CEQA applies only to projects that may have an effect on the environment;
- (2) Authorize the City Manager to execute all grant-related documents pertaining to the Edward Byrne Memorial Justice Assistance Grant (JAG) award in the amount of \$43,334; and
- (3) Amend the Police Department's Fiscal Year (FY) 2024 Operating Budget by recognizing revenue and appropriating \$43,334 in the General Fund (101). (Budget Amendment No. 2024-27)

Recommendation: It is recommended that the City Council:

- (1) Find that the recommended action in the agenda report is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines per Section 15061(b)(3), the "Common Sense" exemption that CEQA only applies to projects that may have an effect on the environment;
- (2) Adopt a resolution for the purpose of the City's participation in the Franchise Tax Board (FTB) City Business Tax Data Program (Resolution No. 10022); and
- (3) Authorize the City Manager to enter into an agreement for tax years 2023 through 2025, which includes data sharing through December 2026. The proposed agreement is exempt from competitive

City Clerk Jomsky introduced the item, and presented information on the additional applications received from those interested in serving on the Charter Study Task Force, and responded to questions.

The City Council expressed appreciation to all of the new applicants that submitted applications to serve on the Task Force, with individual members of the Council expressing support for Gina Dance, Christopher Guerrero, James Oliver Maddox, Diana Carbajal Mejia, and/or Jacque Robinson-Baisley, as well as discussed the merits of increasing the size of the Task Force to 11 or 13 members.

Following discussion, it was moved by Councilmember Hampton, seconded by Councilmember Lyon, to approve staff recommendations Nos. 1 and 2, and to add additional appointments of Jacque Robinson-Baisley and Diana Carbajal Mejia to serve as At-Large members on the Charter Study Task Force (increasing the size the Task Force to 11 members). (Motion unanimously approved) (Absent: None)

Discussion ensued regarding challenges related to increasing the size of the Task Force beyond the 11 members currently appointed, issues related to an even numbered Task Force, the size and composition of the Task Force, as well as the possibility of utilizing alternate members (including their roles and responsibilities) on the Task Force.

Following discussion, it was moved by Councilmember Rivas, seconded by Councilmember Lyon, to expand the Charter Study Task Force to 13 full members, and to appoint Gina Dance to serve as a member on the Task Force.
