Hello,

I am not able to attend tomorrow's meeting (3 pm, Wednesday July 24, 2024) due to work commitments but I wish to speak very strongly in favour of moving the Ramona Senior Supportive Housing to completion as soon as possible.

It is no secret that incomes have not come anywhere close to keeping pace with the cost of housing and as a result more and more people are being forced into homelessness through no fault of their own. In particular, seniors on fixed incomes are particularly vulnerable to ending up on the streets in their remaining years. I had a very dear friend who would have been in that exact same predicament had he not been able to get a place in senior housing, which afforded him a wonderful community of friends for his last few years. He had worked hard all his life, but was dreadfully underpaid for the valuable work he did (home health care) and he simply did not have the savings to afford market level rent.

The "housing first" option is vital as you cannot expect people to "get clean" when they are living on the streets and under tremendous stress and in constant danger. Only when they have a safe and permanent place to live can they begin to heal themselves.

We should not be "warehousing" vulnerable people in secluded areas poorly served by transit where they become isolated and unable to access goods and services and the functions of daily life. The central location of this housing makes it ideal.

This valuable project has been held up in design review for a very long time and it is high time to bring it to fruition. I commend Supervisor Barger and the City Council for continuing to move this forwards.

Housing is an issue in the DNA of the Social Justice Committee of PJTC, thanks in no small measure to our first chairperson, Rabbi Marvin Gross (z'l). Our members are strong supporters of the Ramona Street project and hope that the multi-year process is finally coming to a fruitful conclusion.

We applaud what we understand to be the initiatives of Los Angeles County to expedite planning and permitting that encourages more developers to take on the challenge of planning and building housing that is less profitable than market-rate apartments or condos. Pasadena has work to do in matching the forward-looking policies of L.A. County. Exemplary public-private partnership, the community-building work being done to take maximum advantage of the "710 stub," and the growing commitment to innovation in expanding the housing supply are welcome new directions that will reduce our unhoused and at-risk neighbors.

As a result of a series of our SJC meetings dedicated to thinking about housing as the solution to so many intertwined problems, we discussed the importance not only of government-supported projects but also of the private sector. Increased supply at every level—affordable, middle income, and market rate—will create competition to drive rents down. Reducing the maze of planning, design review, etc is something that governments at the local, county, and state level can and should do.

Thank you all for your inspiring progress in making Pasadena a model of collaboration and foresight in rethinking carbonfree electricity, housing for all of our needs, and transportation.
