Hello,

I am writing in support of the measure to retrofit our beautiful iconic heritage building of the Central Library. I hear there is a City Council meeting discussing this on Monday the 29th. I hope my letter reaches you in time to be counted as a "pro" voice for this measure to fund the library renovation.

I grew up within walking distance of the Central Library and some of the happiest and most wonderful memories of my childhood took place in the courtyard, or in that beautiful high-ceilinged, tapestried entrance space, or perusing through the stacks of the children's section. When I got older I loved rambling through all the levels of the library, making discoveries, studying, enjoying. It was with such sadness I heard that this space has been unsafe for earthquakes and had to be closed. And for some years now its absence as a community locus has been palpable not just to me but to many of my friends and acquaintances!

Though I am a proud US citizen and voter, I am also an immigrant from the Old World, and I have to be honest, in my impression not a lot in the California with which I am familiar really inspires a person with a love of beauty or history. (Some- but not a lot!) The overall philosophy of architecture here seems to build very functional, "postmodern" and even ugly buildings ready to tear down and replace. The Central Library building has seemed to me a luminous, towering exception. It is so sad that it has been closed for so long, and it would be *devastating* to close it forever.

There is something absolutely irreplaceable about this beautiful building. If we were to allow it to decay, stand unused, and perhaps even eventually tear it down, it would be a tragedy. I am not the only person feeling this way. As a volunteer with the Friends of the Pasadena Public Library, I have encountered *so many* people asking about when the Central Library will

open! It commands a place in our imagination not just as a repository for books or even as a social hub of some kind (a "third space" however necessary in our frenetic times). These things are so important, but even they are just a small part of its importance! It is a source of pride for our city, an anchoring in an identity that we people in modern times are in my impression in danger of letting slip through our fingers. We should not! We should preserve and build on our heritage! Imagine if we were to replace this beautiful building with its legendary architecture, inscriptions, history, and lore! It would be terrible. Since I was a kid gaping up at the words "The assembled souls of all that men hold wise," and the names of all those amazing thinkers and writers, (who nowadays even THINKS of Pindar?! we need a reminder!), I was granted access to a whole world of expansive possibilities I might never otherwise have encountered. The cultural, spiritual, civic benefits of such a building simply cannot be overstated. To be deprived our city of this beautiful building would be to deprive the coming generations of what we owe them far more than we owe them even material comfort and convenience. We would be depriving them of soul!

Nobody wants to see a rise in their taxes and honestly this is why I have been hesitant to say anything. It is so easy to be cynical! I am probably not the only person who is a combination of very naive and very cynical (sounds contradictory, doesn't it!?) to politics, to how money is raised and allocated and spent in our bustling California democracy!

But there are noble, vital causes for which we ALL would make sacrifices, and one of these would definitely be to preserve this absolutely iconic building.

I would respectfully urge everybody on the City Council to be unanimous in urging this measure to land on our ballot in November! When the people have a choice and are aware of the full import of this decision, I absolutely cannot imagine that anybody would begrudge even the huge sum (195 million or so I am told) to do right by this piece of iconic architecture which is no less than an instantiation of the beating heart and living soul of our city. To do right by it would be quite honestly to do right by our future generations. Let's leave a Pasadena behind us of which we can be proud - one open for *all* to access the wondrous expansiveness of possibilities, based on history and looking into the future with hope.

Although I've been advised to be brief, I simply couldn't resist, so I thank you for reading and I hope for a wise outcome!

Dear Mayor Gordo and Members of the City Council:

As a member of the Technical Oversight Committee (TOC) for the Central Library seismic retrofit project, I would like to add my voice of support for the ballot measure you are considering this evening.

I have been proud to serve on the TOC and contribute to the effort to save and restore the Central Library. I have been consistently impressed with the knowledge and expertise of my fellow TOC members - an incredible group - and have been greatly honored to serve with them.
