AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 4, CHAPTER 4.52, Section 4.52.020 OF THE PASADENA MUNICIPAL CODE REGARDING SANITATION SEWER USE RATES

The People of the City of Pasadena ordain as follows:

SECTION 1. Pasadena Municipal Code, Title 4 (Sewer Use Fee and Storm

Drain Charge), Section 4.52.020 is amended in its entirety to read as follows:

"4.52.020 - Sanitation Sewer Use Rates.

A. Every <u>customer</u> bill for water use under "the water rate ordinance" where the customer is served by the sanitary sewerage system of the city <u>is shall be</u> subject to <u>a</u>-charge<u>s</u> at the following rates <u>per account</u>:

2. For all other service \$0. 22 / 100 cu. ft.

- B. <u>The city council may, from time to time, amend fees for sanitary sewerage</u> <u>system service by resolution.</u> For all properties served by the city sanitary sewerage system and not under "the water rate ordinance," the following charges shall be made:
 - 1. For all 1, 2, and 3 family units-\$0. 15 / 100 cu. ft. minimum \$4.76 per month.
 - 2. For all other service \$0.22 / 100 cu. ft.
- C. All water introduced into the city sewers from <u>customers not subject to the water</u> <u>rate ordinance</u> any other source including private wells or rain water will be estimated and subjected to this same charge. No charge shall be made or collected on monthly bills where no portion of the water metered goes into the sanitary sewerage system.
- D. The fee schedule will be indexed on an annual basis in accordance with the Consumer Price Index for the Los Angeles/Anaheim/Riverside area."

SECTION 2. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published in full text.
