AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 4, CHAPTER 4.52, Section 4.52.020 OF THE PASADENA MUNICIPAL CODE REGARDING SANITATION SEWER USE RATES

The People of the City of Pasadena ordain as follows:

SECTION 1. Pasadena Municipal Code, Title 4 (Sewer Use Fee and Storm Drain Charge), Section 4.52.020 is amended in its entirety to read as follows:

“4.52.020 - Sanitation Sewer Use Rates.

A. Every customer bill for water use under "the water rate ordinance" where the customer is served by the sanitary sewerage system of the city is shall be subject to a charges at the following rates per account:
