WHEREAS, all human life is precious, and the targeting of civilians, no matter their faith or ethnicity, is a violation of international humanitarian law; and

WHEREAS, Palestinians living in Gaza are being killed at an unprecedented rate. Over 38,000 Gazans – including at least 14,350 children – have been killed or continue to be missing under the rubble – in 193 days, meaning 1 child in Gaza is killed every 10 minutes. Over 300 medical workers and over 100 journalists have been killed. Proportional to population, the death toll in Gaza is the equivalent of about 3.1 million American deaths. In addition, over 71,000 Gazans are wounded, and over 7,000 are missing under the rubble; and

WHEREAS, the Government of The State of Israel has bombed civilian entities indiscriminately, destroying or damaging: at least two-thirds of all homes in northern Gaza; 28 hospitals and 256 medical facilities; 70% of schools; over 600 places of worship; bakeries; refugee camps; roads; and other essential infrastructure.¹ This has destroyed access to food, clean water, healthcare, shelter, and sanitation essential to human life and caused mass displacement of as many as 90% of Gazans; accelerating the loss of life to infectious diseases and starvation, both of which are 100% preventable; and

WHEREAS, the Israeli Defense Forces have blocked the entry of United Nations convoys carrying critical lifesaving supplies, such as food, water, and medicine to the central and northern portions of Gaza; and

WHEREAS, on October 26th, the United Nations General Assembly, in a near unanimous vote, called for an immediate and sustained humanitarian ceasefire; and

WHEREAS, hundreds of thousands of lives are at imminent risk if a permanent ceasefire is not achieved and humanitarian aid is not delivered without delay; and

WHEREAS, the Federal Government holds immense diplomatic and financial appropriations powers to save Palestinian and Israeli lives; therefore

BE IT RESOLVED, that the City of Pasadena, California calls upon our US Congressional delegation, both in the Senate and House of Representatives, to join us in –

- 1) urging the Biden administration to immediately call for a permanent ceasefire and facilitate de-escalation to urgently end the current violence; and
- 2) calling upon the Biden administration to demonstrate leadership and heed the will of the vast majority of the American people and promptly send and facilitate the entry of humanitarian assistance -at the scale needed- into Gaza, including restoring funding to the United Nations Relief and Works Agency for Palestine (UNRWA).
- 3) calling upon the Biden administration to end military support to Israel and shift funding

toward funding essential social services programs here at home.²

BE IT FURTHER RESOLVED, the City of Pasadena, California supports all of its residents and condemns all forms of racism, bigotry, and discrimination, including antisemitism and Islamophobia.

BE IT FURTHER RESOLVED that the Council asks the bodies' staff that copies of this resolution be quickly forwarded to the President of the United States and our Congressional Delegation.

Dear Mayor Gordo and Council Members,

I am writing to you with deep concern regarding the proposed resolution calling for a ceasefire in Gaza. While I understand the importance of peace and humanitarian efforts in conflict zones, it is crucial to address the root cause of the conflict and not simply call for a ceasefire without considering the context.

Israel, a sovereign state, has been subject to unprovoked attacks from Hamas. It is imperative to acknowledge that Israel did not initiate these hostilities; rather, they have been defending themselves against relentless aggression. To blindly call for a ceasefire without condemning the initial acts of aggression against Israel is unjust and only serves to perpetuate the cycle of violence.

I urge you to reconsider the resolution and instead focus on promoting dialogue, condemning acts of aggression, and advocating for the safe release of all hostages. Only through a comprehensive and principled approach can we hope to achieve lasting peace and justice in the region.

Thank you for your attention to this matter, and I trust that you will carefully consider the concerns raised.

My family and I are congregants of Pasadena Jewish Temple & Center (, Pasadena, CA 91107). I learned that the Pasadena City Council will put a resolution for a ceasefire in the Israel-Hamas conflict on the upcoming agenda for March 18. I am squarely against this action.

We should all be deeply disturbed by how local ceasefire resolutions across the country have unleashed the worst behavior in these communities – including at public hearings that invoke dangerous antisemitism – including the denial of (1) the facts of Oct. 7, (2) the legitimacy of the existence of Israel, and (3) the basic human rights of Jews. Such hearings do not advance peace. They do not make local Jewish communities safer. Rather, they put Jewish citizens in these communities at further risk of emotional and physical harm. Do not let this happen in Pasadena.

I urge you to be thoughtful in how you use your platform in the City of Pasadena so as not to do more harm than good and to hold the whole of your local communities' needs in your decisions. Local government bodies should focus on local matters and should not adopt official positions on political issues that are not local to them, as is the case in this situation.

This is in response to the proposed resolution calling for an immediate ceasefire in Gaza, to be considered at the Council's March 18, 2024 meeting.

The City of Pasadena has no jurisdiction, expertise, or even information to justify a resolution calling for an immediate ceasefire in Gaza. Such a ceasefire, without condition, would amount to a victory for the terrorist organization Hamas, which would remain capable of further pursuing its avowed mission of destroying Israel. On October 6, 2023, there was a ceasefire in effect between Israel and Hamas. Hamas broke that ceasefire on October 7, with the rape, butchery, murder and kidnapping of Israeli civilians. Hamas knew Israel would be forced to respond, and they had spent years preparing for such a response. Hamas diverted international funding and aid to Gaza from the civilian population for which it was intended, to the building of a vast tunnel system specifically sited under hospitals, schools and markets so as to use the population above as human shields. What government does that to its own people? Israel's response was both justified and necessary to protect itself. The conflict was initiated by Hamas, and could end tomorrow if Hamas would only surrender and release the hostages it kidnapped from Israel. Responsibility for all the human suffering in Israel and Gaza since October 7 – for every dead Israeli and Gazan, for the thousands who have been wounded in the conflict, for every hungry child and broken family – lies solely with Hamas.

The City of Pasadena has no business passing a ceasefire resolution. Such a resolution would inevitably exacerbate anger and division within the city, while accomplishing nothing of substance, and I urge you to vote "No" on the resolution. Nevertheless, if the council should decide to pass such a resolution, it should be directed to the one party who brought on the conflict and can end it unilaterally – Hamas.

Please include this in the public record.

Dear Members of the Pasadena City Council:

This meeting and its agenda item just came to my attention.

I am the rabbi at Temple Sholom of Ontario in Ontario, California. Even though we are not in your community, this item greatly affects us as it does all Jews everywhere. It is very unfortunate that our fellow Jews and others in Israel have come under physical attack and many have been murdered, taken hostage and died fighting for their country and their lives.

It is even more unfortunate that some vilify and denigrate the Jewish people and hold them responsible for this unprovoked and brutal attack. This is nothing more than antisemitism at its worst. Clearly, any other country would be supported in its mission to eradicate an enemy that brutally murdered innocent civilians. And it is even more outrageous that people are blaming Israel, the clear victim who is by international law defending themselves and making sure this doesn't happen again.

Even beyond this, consider all the actions that the Israel Defense Forces is taking to keep any collateral civilian casualties in Gaza to a minimum; in fact, statistics bear out the claim that fewer civilians have died as a result of the fighting than any other war since these records have been kept. Consider also that they have achieved this while fighting an enemy that wears no uniform or any other distinguishing emblems to separate them as an army separate from civilians.

On behalf of my congregation, my people, and my fellow human beings, I implore you to do the right thing and support Israel in its effort to defeat these terrorists and restore order and prosperity to the region.

Honorable Mayor and Esteemed City Council of Pasadena,

I am writing to request that you vote NO on the resolution regarding a Ceasefire in the war in Gaza. I am a very concerned resident of Los Angeles with deep and abiding ties to your great city. As an attorney, I am honored to represent business clients headquartered in Pasadena and I enjoy the incredible cultural offerings of your city, including my favorite Norton Simon Museum, and the terrific restaurants and shops in Old Town. I travel to Pasadena for excellent medical care, and each year my family and I look forward to attending the famed Rose Parade.

Advocating for a ceasefire in Gaza without conditioning it on the release of all hostages and the surrender of the Hamas terrorist group is immoral and unjust. On October 7, the Jewish people endured their most horrific mass slaughter, rape and pillaging since the Holocaust. Moreover, scores of innocent children, women, and elderly civilians remain in captivity as hostages in Gaza, and thousands of Israeli citizens remain uprooted from their homes due to ongoing missile strikes in Israel. Israel has responded by defending itself from further attack by Hamas, who has repeatedly promised to engage in further slaughter, rape and kidnapping of civilians until Israel no longer exists as a Jewish homeland and the only democracy in the Middle East. Voting on a resolution for an unconditional ceasefire sends a signal to all Jews in your city and beyond that the City Council of Pasadena would be content if October 7th were repeated endlessly until all the Jews in Israel are slaughtered. The resolution would also likely increase antisemitism in Pasadena and beyond.

If your desire is to express solidarity with innocent Palestinian civilians who are suffering greatly in this war (which is a goal that I also share), I respectfully suggest that you consider resolutions asking Egypt, Jordan and other neighboring countries to open their doors and provide a safe haven to innocent women and children as is customary and expected in wars, including the ongoing war in Ukraine. Moreover, perhaps your city could sponsor Palestinian refugees from the war as many United States cities did with Syrians fleeing the horrors of the Assad regime (which I don't recall that you condemned).

Please consider that a ceasefire resolution may tarnish the reputation of your great City (and that of the famed Rose Parade) as well as your standing as ambassadors of tolerance, respect and inclusivity for all peoples. I personally would not feel comfortable continuing my deep ties to your City if the resolution passes.

Honorable Members of the city Council of Pasadena,

I must preface my remarks by cautioning that I will reference several severe incidents, so please be prepared.

The heinous acts perpetrated by Hamas, which has been labeled a terrorist organization by the United States on three occasions, on October 7, 2023, under the pretext of "Liberating Palestine from Jews," constitute a terrifying terror campaign, characterized by genocidal actions, crimes against humanity, and breaches of wartime laws.

The group's intentional dissemination of their violent deeds, particularly the strategic use of sexual violence against civilians as underscored in a recent UN report, has appalled people worldwide. Among these egregious acts, the abduction of women, whose destinies are yet to be determined and who may be suffering unspeakable torments even as we gather here, serves as a grim indicator of the nature of these assaults.

The international community, including the United Nations and UN Women, has vocally condemned these atrocities, pointing out the profound human rights and dignity violations involved.

Moreover, it is essential to delve deeper into the specific barbarities linked to sexual violence perpetrated by Hamas on October 7, 2023. It has been reported that women and girls were subjected to rape, assault, and mutilation in a sequence of actions condemned by the global community, including the Federal government, The United Nations, and UN Women. These actions have been recognized as war crimes and crimes against humanity, underscoring a serious breach of human rights and dignity.

A particularly distressing narrative, highlighted by the New York Times, involves a woman horrifically mutilated. I offer a caution due to the graphic nature of this account – it describes a woman being "torn to pieces" while being raped; meanwhile, another assailant used a box cutter to sever her breast.

An eyewitness recounts: "While one continued the assault, another tossed her breast around as if it were a plaything, eventually discarding it onto the street,"

The witness added that the assailants also cut the woman's face before she disappeared from view. Concurrently, she witnessed the rape of three other women and the terrorists holding the severed heads of three additional women.

These testimonies shed light on the magnitude, range, and distinct nature of the sexual violence executed during the attacks, emphasizing the urgent need for a strong international response to denounce and address such acts of savagery.

Now, five months past these events, I am puzzled and concerned about why our city has yet to officially repudiate these deeds. This raises a critical inquiry about our position and obligations, not only as a municipal authority but as part of the international community committed to upholding human rights and dignity.

In light of this, I propose two potential directions for our council to consider:

1. **Denounce Hamas's Actions:** By taking this route, we would officially criticize the October 7 attacks, aligning our city with the worldwide denunciation of terrorism, genocide, and the exploitation of sexual violence. Such a declaration would affirm our collective commitment to humaneness, justice, and peace, unequivocally denouncing such cruelty.
2. **Concentrate Solely on Municipal Matters:** On the other hand, we could adopt a resolution that reaffirms our dedication solely to local governance, stressing our primary duty to our constituents and the immediate needs of our city. This approach would highlight our commitment to areas within our direct control, recognizing our jurisdictional limits while focusing our endeavors on areas where we can affect the most significant change. This approach follows a recent resolution by Claremont.

If our council opts not to focus exclusively on local matters and feels equipped to delve into global issues alongside the federal government, it is crucial to also express our stance on other notable international conflicts needing attention. This includes the humanitarian crisis in Yemen, the situation of the Uyghur community in Xinjiang, China, and the conflict in Ukraine, all of which are pivotal issues on the global stage. Articulating our position on these issues will ensure a holistic approach to our involvement in international human rights and geopolitical matters.

As Hamas continues to reject a ceasefire agreed upon by the US and Israel, insisting on its original charter's call to "Free Palestine of Jews" and advocating for Jihad, we must remain dedicated to our local community. I appreciate your attention and commitment to judicious governance.

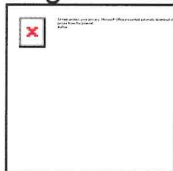

City councils should stay out of Middle East policy issues

Pasadena is the latest city to take up a Hamas-Israel ceasefire resolution

Since October 7, following Hamas' unprovoked attack on Israel, where terrorists killed over 1200 innocent people and kidnapped 253 people, city councils all across the country have received requests to adopt resolutions calling for an immediate ceasefire between Israel and Hamas.

Let that sink in for a moment. People are demanding that city councils, whose public mandate is to be responsible for enacting city policies and laws, weigh in on an international issue as nuanced and complex as the decades-long fight between Israel and Palestinians. These requests require each city, with limited expertise and resources, to address a foreign issue they have no legislative authority over, ultimately taking their attention away from addressing issues that are affecting their city. In essence, city councils are being used to spread anti-Israel sentiment in a large public forum.

This latest effort has now hit Pasadena, with the city council deciding to take up this issue at its March 18 meeting.

While well-intentioned, what city councils fail to recognize is that these resolutions do far more harm than good. Not only do they infer Israel is the root cause of all of the death and destruction in Gaza, they imply that Israel has no interest in peace. Resolutions like this do not account for the fact that if Hamas

immediately returned all of the hostages they stole on October 7; the death and destruction would end. Nor do they demand that Hamas stop its actions from preventing the humanitarian aid from reaching the people in Gaza who so desperately need it. These resolutions also tend not to mention that it was Hamas that broke an existing ceasefire on October 6 when they attacked Israel on October 7. People don't seem to realize that in this latest round of negotiations, Israel has accepted the terms of a ceasefire laid out by negotiators. But Hamas has continually refused. How can Israel be held responsible for there not being a ceasefire when its adversary continues to prevent it from happening?

Often, unbeknownst to city councils, these ceasefire efforts are a means to a further end. Those who are calling for an immediate ceasefire are using this moment to litigate the past and elevate the ongoing struggle of Palestinians. Many supporters' ultimate goal is to further alienate Israel and continue to delegitimize Israel's right to exist through accusations and claims that Israel is an apartheid state or committing genocide. The Jewish community has continued to witness and experience an increase in hate speech and incidents that have targeted Jews these last several months since many people consider Jews to be Israel's proxies. Thus, these efforts further embolden more hate towards Jews along with those who do not support the ceasefire movement.

I understand that people are looking for ways to make a difference and end innocent lives being lost. However, if our congressional leaders, let alone professional negotiators, who are far more knowledgeable than any of us on this issue and intimately know each of the players at the table and have been in the room for the past several weeks, have been unable to pressure each side to agree to the terms of a ceasefire, what makes Pasadena's City Council (or any other city council who is considering similar action) think their symbolic gesture will make it happen? It won't, and these efforts will continue to tear apart the fabric of our society further.

For these reasons (and several others), I urge Pasadena's City Council, as well as any others considering a resolution of their own, to refrain from supporting these efforts and leaving international issues to the experts.

My name is Penina Segall. I was born at Huntington Memorial Hospital in 1974 and have essentially resided in Pasadena since. I am a physician and thus have working knowledge of our city's resources. We rely on the city to help with local issues that affect our community such as public health, housing/homelessness, parks and recreation, public works, and fire/emergency services.

There is a growing mob of disruptive individuals who neither live nor reside in Pasadena that seem to be obsessed with going to multiple city council meetings to spread their misguided ideologies which essentially attempt to divert resources such as staff time to craft resolutions regarding the current crisis in the Middle East. 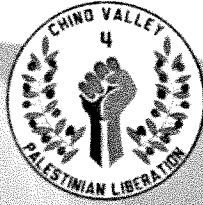

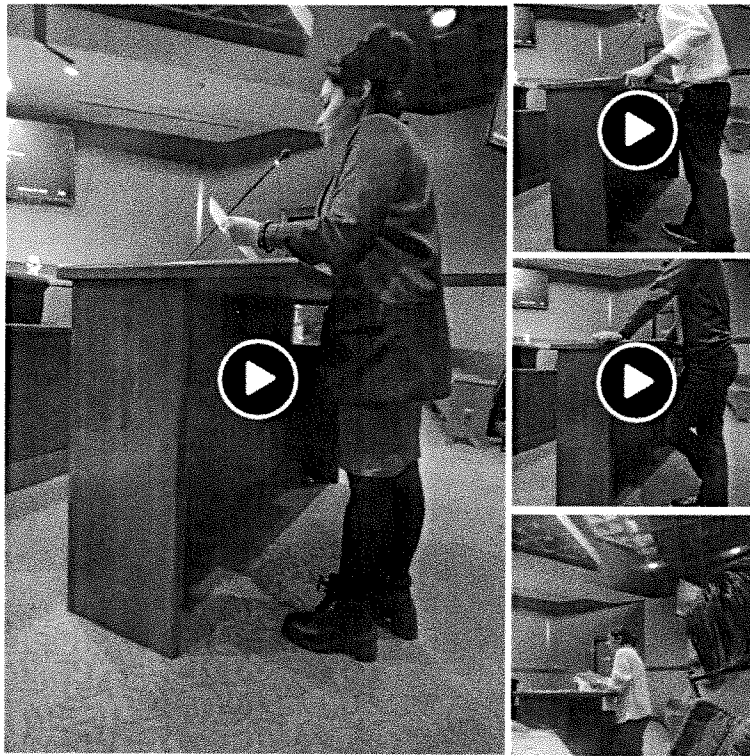

I urge you to oppose the transfer of more weapons of war, which would only intensify this already terrible conflict. Instead, please publicly call for a permanent ceasefire, regional de-escalation, restraint, and respect for international law to prevent further civilian harm. Children are literally starving to death. How does this constitute self defense ? We need to get aid in before it's too late. The port proposed by Joe Biden will take months. It will be too late for the children of Gaza who are innocent. Aid trucks are waiting outside and can be easily let in.

As a long time resident of Pasadena, I wanted to share with you how concerned I am that you are considering a cease fire resolution on Israel/Palestine.

There are three reasons for this:

1. It is a poor use of City resources. This is purely symbolic, and ultimately unhelpful to the residence of Pasadena regardless of the outcome (for or against a cease fire).
2. My first cousin, Sara Duker, was murdered by a Hamas Terrorist in a suicide bus bombing in the 1990's. She was an American, and just happened to get on a bus in Jerusalem which was targeted by a terrorist who killed over 40 innocent people – men, women, and children.
