The monthly rate for a trash <u>bin</u> picked up 1x per week would increase 100% from \$124.70 to \$249.92. 

As a resident of Pasadena I write to oppose the proposed Rate Adjustment to Solid Waste Refuse Collection Fee, not because of the need to cover city costs, but because the rate increase disproportionately burdens the smallest trash producers, the 32-gallon residential cart users. The proposed rate increase for the 32 gallon cart is way out of proportion with the 60 and 100 gallon carts. The increase on the 100 gallon is only 14% in the first year while the increase on the 32 gallon is 52%!!!! A 32-gallon under the new rates. This is grossly unfair and greatly disincentivize conservation and harms seniors the most common user of the 32gallon carts. I switched recently to the 32 gallon cart as my personal effort to reduce my waste production and emphasize recycling. All the while, the biggest waste producers would get the smallest rate increase, riding on the backs of the conservers and many seniors. Therefore, I oppose the proposed rate increase.

The city should rebalance the rate increases to where the rates are proportional to the size of the container, or even lower on the smaller trash producers who are doing their best to conserve.



Some of us have been greatly impacted in a negative way financially and physically from the COVID-19 pandemic and are still struggling to barely manage and pay our bills. The Pasadena lowincome community was already struggling before the pandemic and our situation has only become worse with prices rising all around in food, shelter, basic necessities...etc. We cannot afford another price increase and I strongly urge the city to reconsider and not raise rates at this time.

I'm a renter who lives in the back house with my landlord living in the front house. We are 2 single women who don't generate a lot of trash and only end up using one trash bin for each item: mixed waste, recycling, and yard waste. However, since the property has 2 different addresses I have been told by the city that we are required to have separate bins, even if we don't end up using them. Therefore, in the 9 years I've lived here I have continued to pay for refuse bins we don't use. I understand this is a citywide policy, but it's another policy that should be addressed at some point and possibly changed. This would give residents who are in a similar situation as myself more flexibility and cost savings on their utility bills.

In sharing my personal experience I wanted to call attention to the fact that residents like myself are already paying for bins they may not use and we certainly cannot afford a refuse price increase at this time.

Pasadena Water is the third city department to propose utility rate increases effective July 1, 2024. Although these increases are presented as separate proposals, the effect on ratepayers will be the sum of all three increases on July 1, 2024. Neither the Water nor Sewer fee proposals shows the **combined effect of volumetric and fixed fee increases** on ratepayer monthly bills.

Rates for all three departments (Water, Sewer and Solid Waste) would increase annually for a period of 5 years.

• City Council must consider the combined Impact of rate increases for Water, Sewer and Solid Waste.

Lack of Coordination for Assumptions by Public Works and Pasadena Water & Power

Public Works' (PW) Proposed Sewer Rate structure hides a critical assumption—that an average household's **current usage is 13 hcf** per month but **will drop to 8 hcf** per month for the 5-year period FY2025 – 2029. At the Community Meeting on March 20, a PW staff member stated that current usage of 13 hcf is an average of all rate payers but 8 hcf is the amount PW estimates would actually be diverted into city sewers. **Volumetric sewer rates apply to actual water usage** which Pasadena Water & Power **(PWP) estimates at 11 hcf per month** for its Proposed Water Rate Increase. Charges for both Water and Sewer service appear on the same bi-monthly Pasadena Municipal Services bill. Lack of coordination for assumptions applied to proposed PW Sewer Rates and PWP Water Rates is inexcusable.

• Sewer Rates should be calculated at 11 hcf per month (Agenda Report, 8-Apr-2024, Table 2, p. 6 of 9).





I am protesting the proposed fee increases for refuse collection for the following reason: it does not look to me to be an equitable increase, when I look at current and future rates for a 32 gallon cart vs a 100 gallon cart.

The fee for a 32 gallon cart will double in 4 years. The fee for a 100 gallon cart will increase by 50% in 4 years. Why?

Looking at it another way - a 100 gallon cart is 312% the capacity of a 32 gallon cart. Right now, the fee for a 100 gallon cart is 250% of the fee for a 32 gallon cart, and it will be 188% of the fee for a 32 gallon cart in 4 years.

Shouldn't we be encouraging residents to generate less waste? It seems to me that with these proposed rate increases, the people who are generating less waste will be increasingly subsidizing those who generate more waste.

When I was working it was not a problem, but now I am on a fixed income. I have to pay someone to bring my trash cans up and down. I have had to pay someone to clean out the sewer. The city does not cover any of these costs. It says these fees cover the cost of operating the system, ongoing maintenance and needed capital improvements. In whose neighborhood?? There have been none of these in mine, so what am I paying for??

When the city's tree damaged my sidewalk and bricks on my parkway, the first time the city paid to fix the sidewalk. I had to pay to repair the bricks. The 2nd time a few years ago, they said "we don't do that anymore and you have to pay half." Half was over \$900.00. I had to remove the bricks and put in rocks because the roots are already coming back and I had to pay for that!! I asked them to remove the tree, because over time this is going to happen again. I was told that the tree was healthy, so they wouldn't remove it. I noticed another crack and they have just filled it in with black asphalt causing a bump that someone could trip over and who would be responsible??? What am I paying taxes for??

If they are going to increase the rates on the sewer use, then I want the sewer checked for cracks and cleaned out. That is what we are paying for right??
