NOTICE FOR PUBLIC INPUT

Notice for Public Input for Proposed Room Name Change at Robinson Park Recreation Center

Subject: The City of Pasadena is reviewing a public request to consider renaming the *Dance Room* at the Robinson Park Recreation Center to *Troop Room*. This is one of four options under consideration to recognize Troop, a rhythm and blues (R&B) music group whose members hail from Pasadena. Alternative options include: 1) renaming Dayton Street from Fair Oaks Avenue to Raymond Avenue; 2) installation of a plaque within Central Park; and 3) installation of a plaque at the Pasadena Civic Auditorium. Over the past three decades, Troop has kept ties with Pasadena, and continues to practice at the Robinson Recreation Center Dance Room.

Environmental: This project has been determined to be exempt from the California Environmental Quality Act (CEQA) under Section 15061(b)(3), common sense exemption that CEQA only applies to projects that have the potential for causing a significant effect on the environment; as well as under Section 15301 as a minor alteration of an existing facility with no change in capacity.
