CHAPTER 10.45, SECTION 10.45.220 OF THE PASADENA

MUNICIPAL CODE REGARDING THE PASADENA PLAYHOUSE

PARKING METER ZONE

TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 10, CHAPTER 10.45, SECTION 10.45.220 OF THE PASADENA MUNICIPAL CODE REGARDING THE PASADENA PLAYHOUSE PARKING METER ZONE

PURPOSE OF THE ORDINANCE:

As directed by the City Council on August 19, 2024, this ordinance amends the municipal code to expand the boundaries of the Pasadena Playhouse parking meter zone, and adopts an updated meter rate structure as directed by the City Council on May 20, 2024.

REASONS WHY LEGISLATION IS NEEDED:

The existing boundaries of the Pasadena Playhouse parking meter zone must be revised as originally presented, and added to Section 10.45.220 of the Pasadena Municipal Code. An expanded zone, as described in the surveyor's legal description in Attachment A, is supported by the Playhouse Village Association and Playhouse business owners to allow a broader membership pool to the Playhouse Parking Advisory Commission. This ordinance updates Section 10.45.220 to reflect the district boundaries adopted by City Council on August 19, 2024, and to adjust the meter rate structure, further described in the consultant's report in Attachment B, as adopted by City Council on May 20, 2024, to enhance availability of short-term parking for businesses and merchants in the Playhouse Village area.

PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED:

The Department of Transportation will implement this ordinance.

ENVIRONMENTAL DETERMINATION:

On May 20, 2024, the Council found that this ordinance is not a project as defined in the California Environmental Quality Act (CEQA) Public Resources Code Section 15301 (existing facilities).

FISCAL IMPACT:

Due to the expanded parking meter zone area and adjusted hours of operated, the total discal impact of this action is an estimated revenue increase to the Playhouse Meter Fund (22924017) by approximately \$750,000 in FY2025. Implementation of the expanded meter zone area will have an initial projected cost of \$836,885. The future parking meter equipment operations and maintenance costs are anticipated to cost \$96,628 annually; the annual operating costs for the expanded meter zone will be \$326,628, inclusive of staffing, meter equipment operations, and maintenance.
