Dear Pasadena City Council,

My name is Jonathan Pacheco Bell. I am a resident of Pasadena District 5.

I write this letter in SUPPORT of establishing reasonable campaign contribution limits as outlined in our 9/16 City Council Agenda Item 11. As proposed, campaign contribution limits would reduce from \$5,500 for all races to \$2500 for mayoral races and \$1,000 for city council races.

I support these reasonable campaign contribution limits because:

- Our congressional and state legislative districts encompass larger jurisdictional territories with wider legislative authority, and yet our current city campaign contribution limit of \$5,500 is the same OR HIGHER than theirs.
- Our congressional district has about 464k voters and the limit is \$3,300.
- Our state senate district is 622k voters and the limit is \$5,500.
- My city council district only has 10k voters and the limit is \$5,500.
- Our limits are not proportionate to the size of the races in the City of Pasadena for mayor and council.
- Most people don't have wealthy personal networks that they can use to fundraise. They can't just call up their friends and family and ask them to write fat checks to their campaigns.
- Having a reasonable limit will mean everyday folks are not at such a stark structural disadvantage against candidates with deep-pocketed wealthy friends and family.
- The perception or actuality of elected officials beholden to their biggest and wealthiest contributors is dangerous for our democracy.
- This effort will right-size our contribution limits because:
 - It will promote a more level playing field between candidates.
 - It will minimize monied influence or appearance of influence.

- The enforcement scheme developed by staff is appropriate and cost effective. Per the staff report, enforcement costs will "not be significant."
- It aligns with our values of equitable and fair democratic processes in the City of Pasadena.

Honorable Mayor and Members of the City Council,

Based on the Charter Study Task Force's recommendation and your July 8th decision, I urge you to approve amending Pasadena's Municipal Code to set campaign contribution limits at \$2,500 for candidates for Mayor, and \$1,000 for candidates for City Council districts, per election. Given that Pasadena is currently without limits (defaulting to the State limit of \$5,500), the proposed amounts are consistent with the size of our electorate.

Nowhere is democracy more relevant than at the local level. It is here where the 'rubber meets the road' and a level playing field with respect to fundraising that impacts citizens' right to equal protection and participating in elections must be safeguarded. Without campaign limits the best candidate for the job may be at a structural disadvantage against those with wealthy friends and families—often from outside our City---who can easily write large checks. Without limits the wealthiest campaign contributors may in fact influence their preferred candidate's decision-making or worse, feed the appearance of privilege, which undermines democratic principles and dissuades people from voting. Without limits our democracy is ruled by campaign dollars, rather than a candidate's merit, commitment to service, and guarantee to represent all constituents. To avoid the appearance of undue influence and promote and ensure fair elections, some candidates in Pasadena have voluntarily set limits on the amount they will accept per contributor. Campaign contribution limits need to apply to <u>all</u> candidates.

I strongly urge you to pass the proposed ordinance limiting campaign contributions as set forth therein for the following reasons:

- Strong and meaningful contribution limits prevent wealthy special interests from having undue influence and prevent even the appearance of undue influence, which erodes public trust in the election process;
- High donation limits discourage people who are not wealthy from showing up to vote. And high campaign limits discourage everyday people from running for office;
- □ We should be empowering small-dollar donors to make an impact in campaigns, and we should be setting the campaign limits low enough to encourage voter participation;
- A reasonable limit of \$1000 or lower will go far to increase public trust and voter participation since voters will know that everyone has a voice here in Pasadena.

There has been some previous discussion about the fact that campaign finance reports provide transparency so voters can see who candidates are receiving contributions from, BUT TRANSPARENCY IS NOT ENOUGH. Reviewing campaign disclosures simply confirms that big donors try to buy influence with their elected officials.

There has also been previous discussion, particularly from the mayor, that lower contribution limits cause an increase in independent expenditures. However. NO DATA WAS PROVIDED to the Charter Study Task Force showing that lower limits cause an increase in IEs. Rather, the data showed that there are many variables that can cause an increase in IEs, especially the issues on the ballot.

The ordinance is carefully crafted to minimize any additional cost on the City, allowing for informal resolution for disputed violations of the ordinance.

For all of these reasons, please pass the ordinance expeditiously. Thank you.

Honorable Mayor and Councilmembers:

Since 2021, a broad coalition of Pasadena residents and community organizations has pressed the City Council for reasonable limits on campaign contributions for local races.

Since the successful outcry against the Council majority's efforts to set aside the State limit of \$4,900, those voices have continued to press for reform. Your own Charter Study Committee recommended \$1000 for Council and \$2500 for Mayor campaigns.

While the Council did not follow their urging to provide voters the opportunity to protect those limits by putting them in the City Charter, you did pledge to pass an ordinance expeditiously along with a provision that it could not be set aside or changed during an election cycle.

The history of Pasadena elections demonstrates why these protections are vital. Candidate forums were once common and local media ensured some objectivity in reporting on the claims of candidates. Increasingly, these democratic forms of civic engagement have waned and been replaced by slick, misleading and even malicious professional campaign messages targeted to select audiences. Special interests have come to dominate fundraising in the pursuit of private gain at public expense.

Perhaps \$20 billion dollars will be spent nationally in this election cycle, the costliest and most bitter in history. Voices of reason are drowned out in an orgy of ugly charges and counter-charges, trivializing important national, state and regional issues. WE must not surrender to this degradation of our democracy.

It's true that Supreme Court rulings have hampered the ability to control spending. But let's be sure that candidates cannot be bought and sold by enacting reasonable limits on local races. Ensure as well that adequate provision and resources are made to enforce these limits to avoid their evasion.

I am writing to support LOWER contribution limits and encourage you to support this critically important change to our city government. Below are some of the many reasons why this makes sense for our great City:

- After significant research and mindful consideration, it's what the Charter Study Task
 Force recommended
- o It's what YOU (the Council) voted to do back on July 8th
- o It will right-size our contribution limits
 - Our congressional and state legislative districts are orders of magnitude larger than our voter base, yet our current limit is the same OR HIGHER than theirs
 - Our congressional district has approximately 464k voters, and their limit is \$3,300
 - Our state senate district has approximately 622k voters, and their limit is \$5,500
 - Here at home, our Pasadena City Council districts only have approximately 10k-20k voters, and the limit is \$5,500
 - Our limits are not proportionate to the size of the races for mayor and council.
- o Lower limits will promote a more level playing field between ALL candidates
 - Most people don't have deep-pocket personal networks to call upon to fundraise.
 It's not possible for "regular" or community candidates to call up their well-heeled friends and family and ask them all to write four-figure checks (OR self-fund their campaigns)
 - A reasonable and appropriate contribution limit will mean "regular" people are not at such a HUGE structural disadvantage against candidates with wealthy families and friends
 - It will allow greater access for those who seek elected office.
- o It will minimize actual influence or the appearance of influence
 - The perception (or real possibility) of elected officials being beholden to their most significant contributors is dangerous for our democracy - both in Pasadena and at all levels of elected government - we have a REAL chance to make a difference in our own City
 - It's critical to have a low limit so that it doesn't give the impression that our elected officials are beholden to the people writing the biggest checks.
- The enforcement plan developed by staff is appropriate and cost-effective

- o It will elevate Pasadena governance as a MODEL encouraging other similarly governed municipalities to follow suit
- o State law allows us to LOWER the limits WE need to do it!



As a Pasadena resident and business owner, I am writing to express my strong support for the proposed ordinance to lower campaign contribution limits, which will be discussed at today's meeting (Agenda Item #11). The new limits—\$2,500 for mayoral races and \$1,000 for councilmember races—are a critical step toward creating a more fair and transparent election process in Pasadena, a step the Council voted to take back in July.
