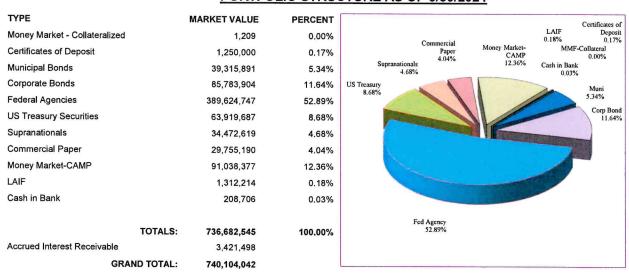

CITY OF PASADENA Capital Endowment Portfolio

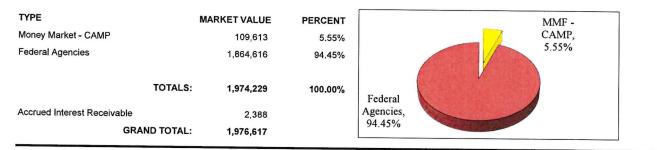

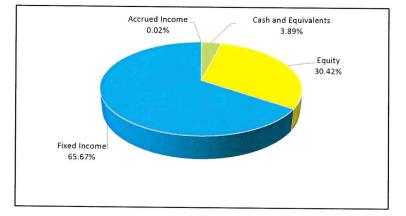

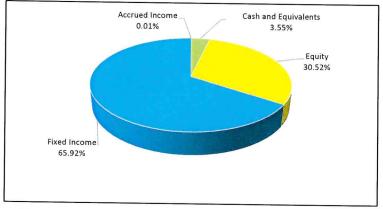
