SUBJECT: AN ORDINANCE AMENDING PASADENA MUNICIPAL CODE TITLE 3. CHAPTER 3.32, SECTION 3.32.270A TO DELEGATE THE MAKING OF

FINDINGS FOR DISPLACEMENT EVENTS TO THE ROSE BOWL

OPERATING COMPANY BOARD OF DIRECTORS

TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 3, CHAPTER 3.32, SECTION 3.32.270A OF THE PASADENA MUNICIPAL CODE TO DELEGATE THE MAKING OF FINDINGS FOR DISPLACEMENT EVENTS TO THE ROSE BOWL **OPERATING COMPANY BOARD OF DIRECTORS**

PURPOSE OF ORDINANCE:

As directed by the City Council on August 19, 2024, this ordinance implements and codifies modifications to the Pasadena Municipal Code to delegate the making of findings for displacement events to the Rose Bowl Operating Company Board of Directors until December 31, 2033.

The Rose Bowl Operating Company also requests that Section 3.32.270A also be modified to allow displacement events to be counted on a fiscal year basis, rather than a calendar year basis. The Rose Bowl Operating Company operates on a fiscal year calendar. This change would help align the occurrence of displacement events with their fiscal impact on the RBOC budget.

REASON WHY LEGISLATION IS NEEDED:

The findings needed to hold more than 15 displacement events per year are codified within Chapter 3.32 of the Pasadena Municipal Code and an ordinance is required to amend this chapter.

On this same date, Council will be asked to find that the proposed amendments are exempt from environment review under the California Environmental Quality Act ("CEQA") pursuant to Section 15061(b)(3), the Common Sense Exemption, that CEQA only applies to projects that may have an effect on the environment.

FISCAL IMPACT:

There is no fiscal impact associated with the adoption of the proposed revisions to the Pasadena Municipal Code.
