

# REPORT ON RENT RELIEF PROGRAMS AVAILABLE TO RESIDENTS IMPACTED BY THE EATON FIRE

April 14, 2025





- Eaton Fire destroyed 117 homes in the City, with substantial damage to another 7 residential units.
- Unknown number of Pasadena residents were impacted financially through the loss or decrease of business or employment income.
- Also unknown is the number of individuals impacted who derive their income from the residential service economy (e.g., child and elderly care, housekeeping, and landscape services).



#### **Council Direction**

- Concurrent with Council approval on 3/3/25 of a motion directing the preparation of a temporary, emergency ordinance prohibiting tenant evictions for non-payment of rent, Council also directed staff to return with a report on potential funding sources for rent assistance.
- This presentation looks at external funding programs, and internal funding streams administered by the Housing Department.

## External Funding Sources and Programs

Department of Housing

#### **Federal Level**

- FEMA Rental Assistance Program provided a temporary grant for interim rental housing while the home is being repaired or rebuilt.
- Program closed on 3/31/25.

### **State Level**

The State has not established a rental assistance program for individuals impacted by the Eaton Fire.

### **County of Los Angeles**

\$32.2M to support to impacted households with grants up to \$18K; program closed on 3/12/25.

### Non-Profit Sector (detailed in Agenda Report)

- Pasadena Community Foundation
  - Approx. \$19 million in donations collected
- **USHS** Eaton Fire Housing Assistance Program
- **Door of Hope** Eaton Fire Hsg Assistance Program
- Pasadena Educational Foundation
  - ➤ Distributed approximately \$1.7 million in assistance to the PUSD community in March
- **Eaton Fire Collaborative**
- One Voice Fire Relief Fund
  - Financial assistance to service workers whose jobs were impacted by the fires PASADENA

### External Funding Sources and Programs

#### **Faith-Based Sector**

- Staff unable to identify Pasadena faith-based institutions that are offering rent relief support on an open basis.
- But many such institutions are providing support to members of their respective congregations.
- Example: The Pasadena Community Clergy Coalition has established an Eaton Fire Relief program that provides financial support to impacted individuals and their families identified through local congregations.

#### **Federal Funds**

- Community Development Block Grant (CDBG)
  - ➤ An annual funding entitlement intended to support community development programs/projects.
  - ➤\$2.45M budgeted in FY 2025 all but \$250,000 committed to projects, programs, and administrative support.
  - ➤ Beneficiaries must be Low income, not exceeding 80% of the County area median income (\$88,800 for a 2-person household).

#### **Federal Funds**

#### Continuum of Care

- ➤\$939K budgeted in FY 2025 for rapid rehousing programming which provides rental assistance and supportive services to households exiting homelessness.
- The funding is subcontracted to Union Station Homeless Services (\$214,000) and Volunteers of America Los Angeles (\$725,000), with the latter designated to serve households with a history of domestic violence.

#### **Federal Funds**

- Emergency Solutions Grant (ESG)
  - ➤ Approximately \$187K is budgeted in FY 2025.
  - ➤ Beneficiaries must qualify as being at risk of or experiencing homelessness.
  - ➤ Beneficiaries must be Extremely Low income, not exceeding 30% of the County area median income (\$33,300 for a 2-person household).
  - City must provide a 100% funding match.

### **Federal Funds**

- ESG-Rapid Unsheltered Survivor Housing (ESG-RUSH)
  - Approximately \$1M awarded to City to assist people experiencing or at risk of homelessness whose needs are exacerbated by disasters.
  - ➤ Beneficiaries must be Extremely Low income, not exceeding 30% of the County area median income.
  - A significant amount of this grant is being planned to provide rental assistance for eligible households experiencing and at risk of homelessness.

### **State Funds**

- Family Homelessness Challenge (FHC)
  - >\$789K awarded to City for homelessness prevention programming which includes payment of rental arrears and short-term rental assistance to families with minor children at risk of homelessness.
  - ➤ Beneficiaries must be Extremely Low income, not exceeding 30% of the County area median income (\$33,300 for a 2-person household).
  - These funds are currently subcontracted to local non-profit Door of Hope.

### **State Funds**

- Homeless, Housing, Assistance and Prevention (HHAP)
  - ➤\$458K awarded to City for rapid rehousing programming which provides rental assistance, move-in costs, and supportive services to households experiencing homelessness.
  - >\$80,000 of these funds subcontracted to Union Station Homeless Services.

### **City-Administered Programs**

- Housing Successor Funds City
  - The projected end of FY 2025 balance is approximately \$478K.
  - Restricted under state redevelopment dissolution law to be utilized for the development, rehabilitation, or preservation of affordable housing, homeless prevention, rapid rehousing services, and administrative costs.

### **City-Administered Programs**

- **Local Solutions Funds from Measure A County** 
  - Approximately \$874K to be allocated to City in July.
  - These funds could be used for rental assistance under the Measure A "Homelessness Prevention" category.
  - Beneficiaries must be precariously housed and/or be at risk of eviction.
  - Beneficiaries must be Very Low income, not exceeding 50% of the County area median income (\$55,450 for a 2-person household). PASADENA



- ✓ Most of the identified internal funding administered by the City are awarded under federal/state programs intended to address homelessness.
- ✓ Such funds are highly proscribed as to allowable uses and beneficiary eligibility, and are restricted from reallocation for broad rent relief.
- ✓ These funds are also subscribed, for the most part, as they are under contract with providers or programmed for allowable uses.



- ✓ There is some assistance available through the nonprofit and faith-based sectors.
- ✓ The use of general fund dollars is not recommended due to economic uncertainty and existing shortfalls for existing programs and uses.
