
Informal polling suggests that many residents in the affected neighborhoods are still unaware of the project. We hope this outreach will help generate momentum and informed participation.





## Planned Changes to Craig Avenue – "Bicycle Greenway"

Pasadena DOT plans to turn Craig Avenue into a Bicycle Greenway

ightarrow A street that would be changed and optimized for bicycle traffic, prioritizing cyclists over motor vehicles

Changes being considered:

- Concrete islands blocking some intersections and some travel lanes
- Roundabouts & traffic circles
- A "road diet" (reducing the number of car lanes)
- Emergency vehicles could be delayed

## Estimated cost: 4 neighborhood streets: ~\$12.6\* million (~9 miles)

For comparison: Union Street Bike Track ~\$8.3 million\* (~1.5 miles)

#### For Your Awareness

## We're concerned the proposed changes to Craig Avenue:

- Overly complicated
- Compromise safety by forcing traffic down neighborhood streets and distracting drivers

- Slated to begin later this year, without widespread communication to impacted neighborhoods

## Specific Changes Being Considered\*

## Proposed Concrete island at Orange Grove & Craig

- · Would block southbound vehicular traffic on Craig
- No more left turns at Craig from Orange Grove (like Home Depot at Foothill & Daisy)

## Proposed Roundabouts at Las Lunas, Villa, and/or Walnut

- · Removes parking in front of homes and businesses
- · Would remove curbside parking due to added red curb zones

## Proposed Road Diet for bike lanes on Craig (between Maple and Corson)

- One lane of traffic in each direction would be removed
- Could cost up to \$300,000 for just 0.3 miles (total Greenways project ~\$12.6M)

## Proposed Concrete island south of Colorado

- Blocks all southbound vehicular access to Craig
- · No left turns from Colorado westbound or right turns from eastbound

- > I have recently been notified by Keep Pasadena Moving about the \$12 million dollar plan to institute road diets, bike lanes, concrete islands, etc., to Craig Avenue and other streets.
- > I am opposed to disrupting the flow of traffic in our City by reducing traffic lanes to increase the number of bike lanes when the City is not serious about educating bicyclists on safety issues.
- > I have talked to you about my concerns over the last few years, and now the Vice Mayor. My concerns seem to fall on deaf ears. In various transportation project proposals that the City has sent out for bid, I have read about educational programs that were part of the proposals. If these programs have been successful, I have not observed positive results from these programs on the street. I see bicyclists riding on sidewalks in busy areas, not observing traffic rules, and not using the new dedicated bicycling lanes when it would be safer for them. As a person who has been nearly run over by bicyclists in Old Town, I take this issue very seriously. If you don't believe me, all you need to do is go out on most any street on most any day and observe the behavior of bicyclists I am speaking of.

> I would be happy to support well-thought out transportation projects if the City could show me its educational efforts have had success. I would like to read the actual educational programs implemented, and the measurable results from these programs showing that the programs are working and the streets are safer. I would also like to see a study on how many people are using the new bicycle lanes as opposed to who are not.

> I am all for transportation projects for various travel modes, but I just want to see the implementation of bicycle lanes rolled out efficiently and effectively, not rolled out for the sake of rolling out -- and possibly just to get State or Federal funding.

Dear counsel members,

We received a flyer from the "Keep Pasadena Moving" organization at our address on Craig Avenue about the proposed Greenways. It seems they are somewhat opposed, but we love the Greenways plan!

We live on Craig north of Colorado and bike commute to work every day. Several of our friends frequently bike from their apartments to ours as well along Craig. The stretch along Craig is by far the most dangerous part of our commute. Drivers rocket off the freeway down Craig, often blowing straight through the stop sign at Walnut. I've probably seen drivers blatantly ignore the stop sign a dozen times. I've witnessed one man on a bike hit by a driver on Craig between Colorado and Walnut and one man on an electric scooter hit by a driver just south of Colorado on Craig. During the school year, I see many parents walk their children down Craig to Hamilton elementary, and crossing both Colorado and Del Mar is so dangerous. We often walk with our baby to Vons for groceries, and I am always afraid when crossing Craig.

My favorite parts of this plan are:

- bike lane on Craia
- roundabout at Walnut and Craig

A few things I would like you all to consider:

1. Craig is a somewhat narrow street, and despite the "no stopping anytime" signs on the east side of S Craig, it seems there is almost always one or more delivery vehicles stopped with their hazards on blocking traffic and making the roads even more dangerous for bikers. Enforcement of the "no stopping anytime" signs during peak traffic hours would go a long way towards "keeping Pasadena moving" without altering the great Greenways plan.

2. Where bike lanes are built, adding flexible bollards on the part separating the bike lane from car lanes, such as in the image below. These would not cause real damage to a vehicle if brushed, but without them drivers simply overlap with the bike lane. This happens frequently on Wilson with the bike lane there. There could be significant gaps for parking access, etc, but the presence of some flexible bollards would go a long way towards biker safety. I would love to be able to take my daughter on these bike lanes, and I wouldn't feel she was safe without these.

#### To those concerned:

I have just received notice of the planned "improvements" to Craig Avenue that are intended to add it to the city's growing "Bicycle Greenway."

I have serious concerns about this whole Greenway project and would like to add my name to those voicing opposition to it.

My complaints go beyond the usual cranky old man yelling at clouds variety and arise out of very specific issues related to how the Greenway has been planned and implemented. Specifically:

#### 1) Who is this serving?

Everyone would like to reduce traffic and the associated environmental/safety issues associated with it. But who specifically is being served by these bikeways? Pasadena is not exactly the West Side of Los Angeles. While the recent growth of dense apartment developments has brought more traffic, and the city continues to face the fallout of the utterly dumb decision made decades ago to build the Gold Line train tracks at grade as they cross two of the city's busiest east/west commuter corridors, traffic in the city is still relatively light. Before it was mucked up by the Greenway project, Union Street carried three lanes of 1-way traffic very efficiently, with plenty of room for cars and cycles. Orange Grove Blvd is typically empty except during rush hour, and even then it still moves along rather speedily. With two lanes of traffic in either direction, there's always plenty of room for cyclists...not that you ever see any. And that's the point. Who is supposed to be using these Greenways? Other than the commercial interests that wish to promote rental bikes, where is the population of bike riders demanding these routes?

The fact is, I rarely see any bike traffic on the new Union Street bike path, and I can't recall ever seeing even a single bike using the Cordoba bike lane. A couple of scooters and a jogger or two, but never a single bicycle. Anecdotal evidence, I know, but that leads to point 2.

#### 2) Review and Adjustment to the Plans

At a community meeting held by Councilmember Rick Cole several weeks ago, I asked if the city had any plans in place or in the works for reviewing the effectiveness of the recent Greenway projects. Were they being used? Were there negative impacts to traffic flow and safety? What have we learned? My question was met with a profound silence. Again, anecdotally, I do regular business at the Logix credit union on the corner of Lake Avenue and Cordoba and can say without a doubt the impact on Cordoba traffic has been awful. Going from two westbound lanes to one has resulted in back-ups sometimes extending well beyond the traffic signal at Mentor. Toss in the very busy driveways leading to and from public parking facilities to the north and south of Cordoba, as well as the colorful jumble of unfamiliar pavement markings and signs, and you've got a mess. So...again...has the city analyzed what has already been done? If so, what has been learned? If not, WHY? This seems like a perfectly reasonable thing to consider BEFORE moving ahead with further Greenway &Idquo;improvements."

While the budget impact of the Craig Avenue work is relatively light, I'm much more concerned with the non-economic impacts of the whole Greenway project. Without sliding into slippery conspiracy territory, I can't help but think that we the lowly citizenry of Pasadena are not being told the whole story of why these developments are being pushed through so rapidly. Until I know WHO they are serving and HOW (or IF) they are working, I urge those in charge to reconsider.

Please STOP the Craig Avenue Greenway work now.

I wanted to write regarding a flyer that I assume was distributed in my neighborhood regarding Craig Avenue and what are purported changes to the road.

I'm wondering if you can help me with some info. Regarding these proposed changes, assuming the flyer is correct, have any traffic studies been done to support or refute the need for these changes? How many, if any, traffic crashes have there been in and around the area of the proposed engineering changes? How many citations for major moving violations have been written in this area? I know "in this area" can be difficult to measure, but if anything has been done specific to Craig/Orange Grove, Craig between Maple and Corson and Craig/Colorado.

Engineering is important, but has there any substantive traffic education campaign launched by the City in general? Specific to these areas?

If problems have been identified, what enforcement has been directed to those areas? The three Es of traffic should be the focus, not just engineering. It has been my experience that other cities, our former employer in particular, focused almost exclusively on engineering. It is my worry that Pasadena is doing the same.

My concern is that the proposed solutions do not have a problem. Is the City spending money from a grant on these things just to spend the money. Is the objective to create traffic and slow down to force commuters onto the rail lines and public transit?

To Whom it May Concern,

I have lived near the intersection of Dudley St. and Craig Ave for nineteen years and I strongly <u>oppose</u> the proposed changes to Craig Avenue for the following reasons:

- In my experience, Craig Ave is not a heavily travelled road and has its own traffic "calmers" by virtue of any of the parked cars that regularly line the street. 80% of the time I drive down Craig Ave, I pull over and allow a car to pass that is coming from the opposite direction. Monday and Tuesday have garbage cans curbside for collection which further impedes traffic flow.
- The newly installed traffic lights at Craig Ave and Orange Grove should suffice to reduce traffic speed on Orange Grove and thus those turning onto Craig Ave from Orange Grove.
- In 2017, I suffered severe injuries from a fall on Dudley St. due to an uneven sidewalk; these included three hair-line fractures, a broken tooth, facial lacerations and multiple bruising. It took almost six months for me to recover. I would prefer to see the money allocated for this proposal be spent instead on fixing sidewalks and some roads where real hazards exist for pedestrians.
- Furthermore, my early morning walks in my neighborhood are disturbed by thunderous traffic noise from the 210 Fwy. (not to mention the noise in my garden ). I have spoken with representatives canvassing at my door regarding this ongoing problem, but it seems that E.Pasadena and NE Pasadena are often overlooked when mitigation, via sound walls, is considered by the city.

Since moving from San Marino in 2006, I have particularly enjoyed living in the Brigder Ranch, NE Pasadena neighborhood and love living in Pasadena in general so I hope my opinion and feelings on this proposal will be well received.
