**DIRECT THE CITY MANAGER'S OFFICE TO EXECUTE
FEDERAL GRANT AGREEMENTS** (Office of the City Manager)

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed action contained in the agenda report is exempt from review pursuant to the California Environmental Quality Act ("CEQA") in accordance with State CEQA Guidelines § 15061(b)(3), the "Common Sense" exemption that CEQA only applies to projects that may have a significant effect on the environment; and
- (2) Direct the City Manager's Office to execute federal grant agreements.

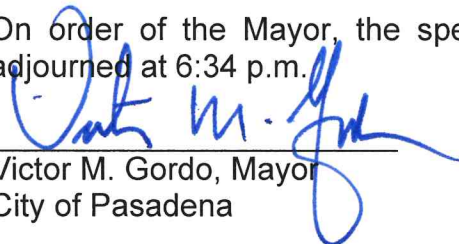
