Councilmember Hampton left the meeting at 11:51 a.m. By order of the Mayor, and consensus of the City Council, the meeting was recessed at 11:51 a.m.

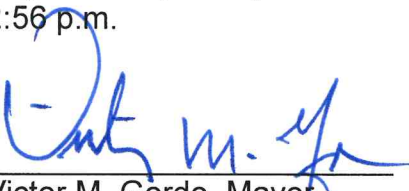
The City Council meeting was reconvened at 12:27 p.m.

returned at 12:32 p.m.

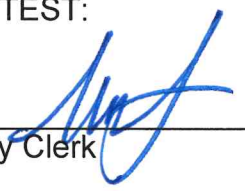

Additionally, the City Clerk and City Attorney would review adopted Councilmember Code of Conduct provisions and incorporate newly adopted meeting guidelines as part of the onboarding of new Councilmembers.
