


- PWP's Wildfire Mitigation Plan ("WMP") proactively reduces Wildfire Risk from electrical infrastructure.
- City Council annually approves WMP updates; PWP oversees implementation (Since 2019).



- Proactively prevent wildfire ignition from PWP electric systems.
- Strengthen electric grid resilience for enhanced stability.
- Drive service reliability and restoration with innovative technologies.
- Continuously optimize wildfire mitigation through data-driven adaptation.





- PWP's WMP utilizes CPUC's High Fire Threat District (HFTD) map
- Cal Fire has recently published a new Fire Hazard Severity Zone (FHSZ) map, which has not been adopted by CPUC.

### Completed Projects

- PWP has completed several key projects to harden the electrical distribution system to include:
  - Installed 34,000 feet of covered conductors in Tier 2 Elevated Fire Risk Areas to enhance safety.
  - > Replaced 100 poles in Tier 2 Elevated Fire Risk Areas. Many with durable sectional composite poles.
  - > Converted 2,000 feet of high-voltage overhead electric system in Millard Canyon (Tier 3 Extreme Fire Risk) to low voltage, reducing fire risk.
  - Proactively inspected and repaired 548 poles in Tier 2 Elevated Fire Risk Areas, ahead of the GO165 schedule.
  - Enhanced vegetation management program in Tier 2 and 3 area

# Ongoing and Future Projects

- Targeted pole and transformer upgrades in Tier 2 Fire Threat Areas, based on recent inspection and modeling data.
- Enhanced vegetation management program in Tier 2 and 3 area
- Accelerated undergrounding of high-voltage lines in Canyon Close Rd. & Fox Ridge Dr. (Tier 3 Extreme Fire Risk) in FY 2026.
- Accelerated undergrounding of high voltage lines in Florecita & Crestford Dr. (Tier 3 Extreme Fire Risk) in FY 2026.

# Ongoing and Future Projects

- Underground expansion projects in the Upper Hastings Ranch area to provide underground feeds to Thomas and Don Bonito Reservoirs. Targeting FY 2027 completion
- Evaluating undergrounding of additional Tier 2 areas.
- Initiating Public Safety Power Shutoff Program Evaluation (RFP for Third-Party Analysis).



 California Public Utilities Code ("CPUC") 8387 mandates annual WMP submissions to Wildfire Safety Advisory Board ("WSAB") for review of current fire mitigation strategies.

 2025 WMP aligns with 2024 plan and follows WSAB recommendations.



 Approve the 2025 Wildfire Mitigation Plan as the operating manual for wildfire risk mitigation, fulfilling CPUC 8387 requirements.
