I am a professional environmental scientist, customer of PWP, and survivor of the Eaton Fire. Pasadena needs to come to consensus, we are in analysis paralysis mode when it comes to how to actually get to carbon free power by 2030.

We can keep studying how to best proceed but we can't actually move forward without a plan of how to get to 2030's goal and we are quickly running out of time. Meanwhile, the stakes have never been higher. With the federal government back peddling on climate action, friends and neighbors loosing everything to the costliest climate disaster yet, and carbon emissions climbing, Pasadena has an enormous responsibility to move in the right direction, take action for its utility, its people, and its future before it is too late.

We need a plan to actually get us to carbon free renewable power and we need to be already in the process of implementing this plan or else we risk inaction and not moving forward until it is too late. My name is Lisardo Duran Jr., and I am writing today as a veteran, community leader, and environmental advocate. I currently serve as the Post Commander of VFW Post 3208 and Judge Advocate for VFW District 11. I am also a proud member of the Military Order of the Cootie.

After years of military service, many veterans—myself included—have turned to nature-based practices as part of our healing and recovery from physical and mental injuries. Beekeeping, gardening, and reconnecting with the land have become powerful, organic methods of restoring health and purpose in civilian life.

I am a Master Beekeeper with the U.C. Davis Master Beekeeping Program and a member of the Los Angeles County Beekeepers Association, the Beekeepers Association of Southern California, and the Botanical Society of America. These roles have deepened my understanding of how essential pollinators, plants, and healthy ecosystems are to both human well-being and climate resilience.

With this lived experience, I am deeply concerned that Pasadena's proposed operating budget includes insufficient investment toward our 100% carbon-free electricity goal—unanimously

adopted in the 2023 Climate Emergency Resolution. That resolution cannot be allowed to sit idle. We need measurable, funded steps toward clean energy now.

It is our responsibility to act with integrity and purpose—not only for ourselves, but for future generations, for the nation's veterans seeking peace and healing, and for the vital ecosystems we all depend upon.
