Privacy and Cybersecurity

The staff reports rates that "a multi-department selection team of 11 City staff members completed the [AMI RFP] evaluation"

- 1. Did the City staff team evaluate AMI cybersecurity and privacy concerns?
- 2. In what ways is the City addressing cybersecurity and privacy issues with AMI use?
- 3. Will the City obtain consumer consent to share data with third parties? Will consumers have the option to opt out of the sharing of their data?
- 4. What are the costs and life expectancy of the meters and related communication equipment and software, the reliability/resilience benefits, and justification of the benefits and costs?
- 5. Are there data governance plans or appropriate changes to data architecture and a comprehensive master data management agreement that address concerns?

According to research and historical data, "AMI's data storage and communication method make the AMI system more vulnerable to different threats and cyber-physical attacks."2

The ACEEE (American Council for an Energy-Efficient Economy) states the need to "ensure that the investment has adequate cybersecurity protections, that customer privacy is protected, and that utility costs may be substantial while customer benefits may not be equitable across a customer class."3

It is high time the City implements a comprehensive privacy program...for our safety and security.
