**CEREMONIAL MATTERS** Eugene Harris, Police Chief, and Susana Porras, Pasadena Police  
Department Senior Communications Coordinator, introduced newly  
sworn in Pasadena Police Officers. The City Council welcomed the  
new officers and expressed gratitude for their serving the City.

Mayor Gordo presented a proclamation declaring the month of  
October 2025 as Bullying Prevention Awareness Month and United  
Against Hate Week. Elliot Park, Pasadena youth member, and  
Sandy Greenstein, Human Relations Commissioner, thanked the  
City Council for the recognition and spoke on the importance of  
bullying prevention. Commissioner Greenstein also invited the City  
Council and the community to attend the Walk to Freedom event on  
Saturday, October 25, 2025.

Mayor Gordo issued a proclamation declaring October 2025 as Walktober and Pedestrian Safety Month. Joaquin Siques, Director of Transportation, thanked the Mayor and City Council for the recognition and introduced Colin Bogart, from Day One, and Liz Schiller, from Pasadena Complete Streets Coalition, who invited the City Council and community members to participate in Walktober events, with various opportunities to explore the City on foot.

Mayor Gordo requested that the meeting be adjourned in memory of Jane Goodall, an anthropologist and pioneer in primate ethology. He acknowledged her serving as the Grand Marshall of the 124<sup>th</sup> Tournament of Roses Parade in 2013, and her planned appearance on October 1, 2025 in Pasadena to launch TREEAMS, a student-led movement to plant over 5,000 trees in recent fire-ravaged areas.

Councilmember Madison also requested that the meeting be adjourned in memory of Sidney Kirkpatrick, longtime Pasadena resident and bestselling author, and spoke on his contributions to Pasadena Central Library and system in 1993 by helping to promote and support the passage of the original Library Tax.

**AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH VITAL MEDICAL SERVICES, LLC FOR NON-EMERGENCY MEDICAL SERVICES TO INMATES FOR A PERIOD OF FIVE YEARS IN AN AMOUNT NOT-TO-EXCEED \$1,607,250 (PDD)**

**Recommendation:** It is recommended that the City Council:

- (1) Find the proposed action in the agenda report is exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15061(b)(3), the "Common Sense" exemption that CEQA only applies to projects that may have an effect on the environment;
- (2) Authorize the City Manager to enter into a contract without Competitive Bidding pursuant to City Charter Section 1002(F), contracts for professional or unique services with Vital Medical Services, LLC for non-emergency medical services to inmates housed in the Pasadena City Jail for five years not-to-exceed \$1,607,250 which includes Consumer Price Index (CPI) adjustments and a 10% contingency of \$146,115 (Contract No. 33409);
- (3) Grant the recommended contract an exemption from the Competitive Selection process pursuant to Pasadena Municipal Code section 4.08.049(b) contracts for which the City's best interest is served; and
- (4) Authorize the City Manager to approve no-cost amendments to the subject contract including durational extensions.

**ADOPT A RESOLUTION ESTABLISHING TWO NEW CLASSIFICATIONS AND UPDATING THE SALARIES OF TWENTY-FOUR EXISTING CLASSIFICATIONS REPRESENTED BY PMA, IBEW, AND NON-REPRESENTED MANAGEMENT (Human Resources Dept.)**

Vice Mayor Rivas returned to the meeting at 6:55 p.m.

**MILITARY EQUIPMENT ANNUAL REPORT AND RENEWAL OF EXISTING MILITARY EQUIPMENT (Police Dept.)**

**Recommendation:** It is recommended that the City Council:

- (1) Find that the action proposed in the agenda report is not a “project” subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 21065 and within the meaning of Section 15378(b);
- (2) Find that each type of military equipment identified in the Pasadena Police Department (PPD) June 2024 through June 2025 Annual Military Equipment Report has complied with the standards for approval set forth in the PPD Military Equipment Policy 711 and Government Code Section 7070 et seq.; and
- (3) Approve the continued use of the currently authorized military equipment by renewing Ordinance No. 7395 pursuant to Government Code Section 7071(e)(1).

Katie, San Gabriel resident, expressed concerns related to the Pasadena Police Department's budget for military equipment and heightened tensions in the community due to federal immigration activities.

Yadi, Pasadena resident, expressed concerns related to personal privacy and the Pasadena Police Department's use of drones.

In response to Vice Mayor Rivas' inquiry regarding opportunities for feedback and input from the public and the Community Police Oversight Commission (CPOC) on the Police Department's Annual Military Equipment report, Anthony Russo, Police Lieutenant, confirmed that the report was presented at a community meeting, as well as to the CPOC, and neither had concerning comments. He also noted that City staff incorporated language requested by CPOC into the Military Equipment report.

Vice Mayor Rivas advocated for the Police Department's policy to explicitly state that the sole purpose and authorized use of the .50 caliber rifle is to disable vehicles being used in an attack scenario.

Councilmember Cole advocated for future reports to be agendaized for the City Council to review and offer feedback and recommendations to the Police Department.

Councilmembers Hampton and Cole advocated for future reports to include a description of the feedback and recommendations provided by the CPOC to the City Council.

Lieutenant Russo clarified that there is a procedural legal requirement that precludes the CPOC from making recommendations on the matter. Mayor Gordo also stated that while the information is presented to the CPOC and the public for transparency purposes, the City Council, as elected representatives of Pasadena, are singularly empowered with decision-making authority regarding Police equipment and other related public safety policies.

**ADOPTION OF A RESOLUTION TERMINATING THE LOCAL PUBLIC HEALTH EMERGENCY ISSUED BY DECLARATION OF THE HEALTH OFFICER IN RESPONSE TO THE EATON FIRE EVENTS AND WINDSTORM CONDITIONS IN THE CITY OF PASADENA (Health Dept.)**

**Recommendation:** It is recommended that the City Council:

- (1) Find that the proposed action in the agenda report is not a “project” subject to the California Environmental Quality Act (CEQA) pursuant to state CEQA Guidelines Section 21065 and within the meaning of Section 15378(b); and
- (2) Adopt a resolution terminating the Local Public Health Emergency issued by Declaration of the Health Officer in response to the Eaton fire events and windstorm conditions in the City of Pasadena. (Resolution No. 10155)

City Manager Márquez provided introductory remarks on the item.

In response to Councilmember Masuda’s inquiry about additional soil testing efforts, Manuel Carmona, Public Health Director, reported that LA County coordinates a free soil-testing program that offers composite testing for people on private residential properties. He also reported that the County does publish the test results online.

In response to Councilmember Madison’s inquiry regarding persons impacted by lead and other fire-related pollutants, Public Health Director Carmona reported that Quest Diagnostics is providing free lead-detecting blood tests throughout the County. Councilmember Madison requested that the City test and monitor lead levels and impacts to first responders. He also advocated for the Public Safety Committee to receive a report addressing the City’s and the County’s after-action analysis.

Katie, San Gabriel resident, expressed concerns regarding the City’s evacuation response to the Eaton Fire.

In response to public comment, Mayor Gordo reported that the City is schedule to recognize the members of the Job Center and supporters for their efforts in response to the Eaton Fire.

Mayor Gordo suggested that the City monitor employees impacted by the Eaton Fire and provide additional testing opportunities, and to develop a heat map indicating where elevated levels of lead are being detected so that the City may conduct additional outreach and testing for residents.

**AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH TDG ENGINEERING, INC., TO DELIVER CONCEPTUAL DEVELOPMENT, PRELIMINARY ENGINEERING AND FINAL DESIGN SERVICES FOR PASADENA GREENWAYS FOR A TOTAL AMOUNT NOT-TO-EXCEED \$1,092,594 (Transportation Dept.)**

**Recommendation:** It is recommended that the City Council:

(1) Find that the action proposed in the agenda report is not a "project" subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 21065 and within the meaning of Section 15378(b); and

(2) Authorize the City Manager to enter into a contract with TDG Engineering, Inc., as the result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, for professional engineering services for the Pasadena Greenways in the amount not-to-exceed \$1,092,594, which includes the base contract amount of \$586,313 to develop conceptual and preliminary design (Phase 1), the option for additional services to deliver Final Design including Plans, Specifications and Estimates (PS&E) in the amount of \$406,281 (Phase 2), and a contingency amount of \$100,000 for any necessary change orders subject to City Manager approval. Competitive price bidding is not required pursuant to City Charter Section 1002(F) (contracts for professional or unique services). (Contract No. 33330)

*(Discussed and considered concurrently with Item No.7, including for public comment purposes.)*

Mayor Gordo, Councilmember Jones, and Vice Mayor Rivas all stated conflicts of interests with the item due to the proximity of personal property near proposed project areas, recused themselves from the item, and left the meeting at 7:40 p.m.

In response to Councilmember Madison's inquiry questioning the need for recusal by members of the City Council given the seemingly citywide impacts of the proposed project, City Attorney Bagneris reported that the City Attorney's Office reviewed the Fair Political Practices Commission's opinion letters, calculated potential impacts for each member of the City Council, and advised those members with apparent conflicts of their need for recusal, which included Mayor Gordo, Vice Mayor Rivas, and Councilmember Jones.

City Clerk Jomsky reported out correspondence received by the City Clerk's Office for the September 8, 2025 City Council meeting (from when the item was originally agendized), which included 32 letters in opposition to the staff recommendation and/or expressing concerns with the City building concrete islands that would block travel lanes throughout the City (22 of the letters from Pasadena residents, 2 from non-residents, and 8 with residence not stated), 160 letters in support of the staff recommendation and/or providing comments in support of the Greenways Plan (119 of the letters from Pasadena residents, 37 from non-residents, and 6 with residence not stated), 2 letters providing information on the matter, letters of support from various local organizations, data from Safe Greenways supporters, and a list of 1,022 names of individuals in support of the proposed Greenways Plan. He also reported out correspondence received by the City Clerk's Office for tonight's City Council meeting, which included 48 letters in opposition to the staff recommendation and/or expressing concerns with the City building concrete islands (37 of the letters from Pasadena residents, 1 from a non-resident, and 10 with residence not stated), 40 letters in support of the staff recommendation and providing comments in support of the

Greenways Plan (35 of the letters from Pasadena residents, 2 from non-residents, and 3 with residence not stated), and 1 letter with a list of 26 names of individuals who are in opposition to the Greenways Plan. City Clerk Jomsky reported that all correspondence listed above was received by the City Clerk's Office, distributed to the City Council, posted online, and made part of the public record for this item.

Transportation Director Siques presented a PowerPoint presentation on the item, providing information on the two phases of the project, the project scope of work, outreach efforts, and Measure R Mobility Improvement Project funding.

In response to Councilmember Masuda's inquiries regarding impacts on the accessibility of emergency vehicles and the slowing of traffic, Transportation Director Siques reported that City staff will work with the Fire Department to ensure that response times are not affected, and that public safety remains a priority. He also stated that the proposed plan is not intended to cause major traffic or backup since the streets are low-volume streets. He reported that the purpose of reducing the speed limit in these corridors is to enhance safety for all road users, including pedestrians and bicyclists.

Suzanne Madison, Allegra consulting, spoke on the importance of supporting local businesses and advocated for her firm's experience with public engagement.

Councilmember Lyon spoke in support for City staff to consider contracting with local firms in Pasadena and possibly adjust the scoring mechanism to give more weight to local businesses during the bidding process.

Councilmember Cole requested City staff to include the Transportation Advisory Committee as part of the oversight for the proposed project and to build upon the City's commitment to traffic safety. Transportation Director Siques confirmed that the Transportation Advisory Committee is already involved in the process and the project initiatives.

**AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT AGREEMENT WITH ARELLANO ASSOCIATES TO PROVIDE COMMUNICATIONS AND PUBLIC ENGAGEMENT FOR SIX NEAR TERM SR 710 PROJECTS FUNDED THROUGH MEASURE R MOBILITY IMPROVEMENT PROJECT (MIP) FUNDS FOR A TOTAL AMOUNT NOT-TO-EXCEED \$970,000 (Transportation Dept.)**

**Recommendation:** It is recommended that the City Council:

(1) Find that the action proposed in the agenda report is not a "project" subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 21065 and within the meaning of Section 15378(b); and

(2) Authorize the City Manager to enter into a contract with Arellano Associates, as the result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, for professional communication and public engagement services for six near term SR 710 Projects funded through Measure R Mobility Improvement Project (MIP) funds in the amount not-to-exceed \$970,000 which includes the base contract amount of \$929,964 and a contingency amount of \$40,036 for any necessary change orders subject to City Manager approval. Competitive price bidding is not required pursuant to City Charter Section 1002(F) (contracts for professional or unique services). (Contract No. 33413)

*(Discussed and considered concurrently with Item No.6, including for public comment purposes.)*

Discussion ensued regarding the bidding process and selecting local companies that are rooted in the community.

In response to Councilmember Madison's inquiry regarding the required public outreach, Transportation Director Siques reported that public outreach is required by the funding agency and by the City's own process.

Councilmember Madison expressed concerns that the required outreach component may block necessary projects from moving forward given that the outreach must indicate the need for the projects. He also advocated to give more weight to local vendors in the bidding process.

Councilmember Cole advocated for the City to enhance consistency in branding and engagement for all projects, to provide effective community engagement services for the City, and to provide centralized staff support for public engagement rather than dependence on outside vendors and contractors.

In response to Councilmember Madison's inquiry about the consequences if the contract is not approved, Transportation Director Siques reported that City staff would restart the outreach model, which will delay the project moving forward. He elaborated that the funding is awarded through the end of the construction and does not include the timing for the design model.

City Manager Márquez reported that City staff does have a citywide outreach engagement team spread throughout various departments and will work to identify ways for alternative approaches to developing and enhancing community dialogue.
