AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH UNITED PACIFIC SERVICES INC., FOR CITYWIDE TREE PLANTING FOR AN AMOUNT NOT-TO-EXCEED \$297,000 (Public Works Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find that the action proposed in the agenda report is not a "project" subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 21065 and within the meaning of Section 15378(b); and
- (2) Award contract to the lowest responsive and best bid dated September 22, 2025, submitted by United Pacific Services Inc., in response to specifications for Citywide tree planting, authorize the

City Manager to enter into a contract for an amount not-to-exceed \$297,000 which includes the base contract amount of \$270,000 and a contingency of \$27,000 to provide for potential change orders. (Contract No. TBD)

Mike Polka, Pasadena resident, expressed his concerns regarding the City's approach to tree planting, including the budget and planting schedule.

In response to Councilmember Hampton's inquiry regarding the City's tree planting schedule, Michael King, Forestry Program Coordinator, reported that the City's planting season typically starts in the fall and concludes by the end of spring. He noted that there were delays earlier this year, which led to planting work concluding in June before experiencing heat waves.

In response to Councilmember Cole's inquiry regarding the responsibility of contractors to replace trees that died just after planting, Forestry Program Coordinator King reported that City staff will review the terms of the current contract for tree replacement provisions and ensure the contractors meet their obligations under the contract. In response to Mayor Gordo's inquiry regarding the performance standards in the contract, Forestry Program Coordinator King stated that the current contract specifications state that the planting and installation contractor is responsible for maintaining the health and conditions of the trees until September. Mayor Gordo and Councilmember Cole advocated for the City to pursue the contractor's responsibilities in terms of performance standards and quality assurance.

CONSIDERATION OF A CALL FOR REVIEW OF THE BOARD OF ZONING APPEALS DECISION TO THE CITY COUNCIL REGARDING HILLSIDE DEVELOPMENT PERMIT NO. 7134, TO ALLOW A NEW 4,280 SQUARE-FOOT, TWO-STORY SINGLE-FAMILY DWELLING WITH AN ATTACHED 2,685 SQUARE-FOOT SIX-CAR GARAGE, FOR THE PROPERTY LOCATED AT 1530 SCENIC DRIVE (Councilmember Madison)

Councilmember Madison provided a brief overview of the item and his decision to call for review.

Councilmember Cole noted that the Board of Zoning Appeals voted unanimously on the matter and expressed concerns that having the City Council review the matter due to disagreement with the Board's decision may potentially preclude the need of having a Board of Zoning Appeals. Vice Mayor Rivas echoed similar sentiments and expressed concerns regarding the efficient use of City staff time and resources for a process that appears to be non-controversial.

Mayor Gordo noted that a group of residents have already appealed the decision, which obligates the City Council to revisit Board of Zoning Appeals' decision. Councilmember Madison's request is also consistent with the City's Municipal Code and the appeal process.

Councilmembers Hampton and Jones expressed support for the call for review and for the City Council to hear the residents' concerns.
