- (2) Adopt the City Treasurer's recommended Investment Policy and Investment Strategy for Fiscal Year 2025-2026 (FY 2025-2026).

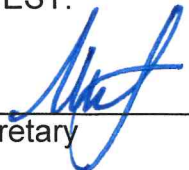

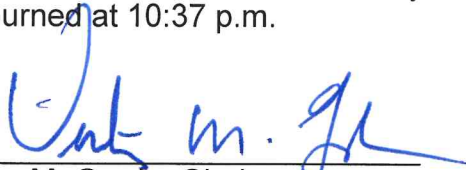
