It is time for the council to join the PSCC President, executive committee, & board to endorsed Guanajuato proposed affiliation recommendations and

articulate its support for the proposed affiliation of Guanajuato as a Pasadena sister city. It should further acknowledge and formally embrace El Presidente Samantha Smiths historic visit to Pasadena and immediately respond to her invitation to visit Guanajuato during the Cerventine festival, day of the dead and special events for our delegation.

Subject: Public Comment

For more than three decades, I have volunteered as a citizen diplomat. I've traveled to over 20 countries, through official delegations and cultural-education exchanges. These experiences reinforced my conviction that international exchange is essential to our humanity. It builds understanding, mutual respect, and peace.

As a member of the Guanajuato Proposed Affiliation Ad-Hoc Committee, I affirm along with several council members and members of the Latino community—that every requirement of the Sister Cities Affiliation Policy (SCAP) has been met and repeatedly approved by the PSCC Executive Board but Executive Board has failed to calendar the approval of the Guanajuato PA Ad-Hoc Committee before the city council as promised. I know this to be true because I was in the meeting when Lena Kennedy herself gave her approval. Yet now she denies it, implying the committee is out of order, while Mayor Gordo uses her words as cover to continue delaying.

Together, they undermine both the evidence and the will of the people. Their actions already speak louder than their words. The facts are undeniable: the requirements are complete, the Executive Board has approved, and the people of Pasadena support this initiative. The time for delay is over.

Despite repeated correspondence, there has been no acknowledgment and no action. This is not a breakdown in communication. It is willful neglect. It is a breach of fiduciary duty by Lena Kennedy, and the lack of response to the community from Mayor Victor Gordo.

The consequences have been profound. There is a public outcry regarding the misinformation of the Mayor's false statement about the Guantajuato Proposed Affiliation process that has complied with all the guidelines as outlined in the Sister Cities Affiliation Policy (SCAP) description. Additionally, more than 30 dedicated members of PSCC have departed in frustration, and have organized a separate program which is operating with full compliance. The program has now gained traction. This division has weakened Pasadena Sister Cities, diminished public confidence, and eroded the credibility of our affiliation process. In social justice terms, this is an inequitable and exclusionary outcome, one that denies both our local community and our international partners the opportunity for full participation.

The Latino community, along with civic leaders and organizations across Pasadena, stands firmly in support of this affiliation. Their position reflects equity, inclusion, and accountability. These are principles that must guide all civic partnerships.

The first week of January 2025 the Guanajunato Delegation visited Pasadena.

Lena Kennedy essentially forced this committee to receive the delegation to Pasadena as 'unofficial,' making that point loud and clear. Yet after undermining the committee publicly, she and the Mayor quietly reversed themselves—whether out of embarrassment, shame, or recognition of their mistake—by eventually meeting with the mayor of Guanajuato.

The Guanajuato PA Ad-Hoc Committee members showcased the best of Pasadena. The highlight was a cultural exchange at Marshall Fundamental School. In attendance were the President of Pasadena City College, the Superintendent of Pasadena Unified School District, and nearly one hundred educators and students. The dialogue was rich. The collaboration was meaningful. The promise was undeniable. And a number of participants questioned why Mayor Gordo and Lena Kennedy were absent.

On a personal note, I was deeply moved to see a photograph of my niece, Madison Triplett—the 2015 Tournament of Roses Parade Queen—displayed at Marshall. That image reminded me of our mission. To nurture ambassadors for the future. To give young people the chance to flourish as global citizens.

Again, despite this readiness and overwhelming support, progress has been obstructed. That obstruction undermines the dignity of our city. It frustrates duly authorized objectives. It places Pasadena at risk of being seen as unjust and noncompliant. The corrective action is clear: a formal signing of the affiliation agreement by the mayors of Pasadena and Guanajuato.

It is also worth noting that Lena Kennedy recently announced that she will not seek another term. With her departure, Pasadena Sister Cities has the opportunity—and the responsibility—to restore governance, rebuild trust, and move forward with integrity.

As a nonprofit operating under the State of California, Pasadena Sister Cities (to my knowledge) has not been in compliance since its inception. We have no liability insurance whatsoever—a fact I have raised repeatedly. Beyond that, the student exchange program lacks proper parental permission forms, notarized medical authorizations, host families criteria, hold harmless agreement, and other critical legal and safety documents required to safeguard minors in international travel. This failure exposes our students, families, and the organization itself to serious legal and financial risk. While liability insurance is not mandated for every nonprofit depending on its structure, the complete absence of coverage, combined with missing documentation, places Pasadena Sister Cities in ongoing jeopardy.

This is not merely an organizational failure; it reflects a lack of oversight by our public officials. By failing to monitor compliance, PSCC has allowed this condition to persist unchecked, making the City complicit in decades of noncompliance. Such negligence jeopardizes not only Pasadena Sister Cities but also signals broader risks among other nonprofit organizations under the City's purview.

The time for delay is over. It is time for Mayor Gordo and Councilmembers to stand with the people, take responsibility, and sign the agreement.

President Dwight D. Eisenhower said: "For the peoples of the world to live together in peace, they must first learn to know and understand each other." That vision must guide us now. That vision is foundational to the Pasadena City Council legacy.

I respectfully urge this Council to respond to the Pasadena community outcry by acknowledging the strong relationship that has been built between Guanajuato and Pasadena and place the Proposed Sister City Affiliation on the next agenda for approval and execution.
