Re: Process for Establishing a Mexico Sister City

Honorable Mayor Gordo and Councilmembers,

This letter outlines facts relevant to the establishment of a Mexico Sister City and adherence to the Pasadena Sister Cities Committee (PSCC) bylaws and procedures, which are intended to uphold transparency, nonprofit status, and credibility with international partners.

#### Category 1: Membership Timeline & Entry

- In October 2023, Rene Gonzalez approached then-PSCC Membership Chair Michael Warner regarding membership. Mr. Warner informed him that he would need to wait until 2024.
- Mr. Gonzalez consulted former Mayor Terry Tornek, who directed him to follow Mr. Warner's guidance.
- Mr. Gonzalez then contacted then-Executive Board member Lena Louise Kennedy, who informed him that under PSCC bylaws, he was eligible to join immediately.
- Membership before November 2023 made Mr. Gonzalez eligible to vote in the December 2023 election, as the bylaws require 30 days of membership before voting rights apply.

#### Category 2: Commitment to a Mexico Sister City

- Mr. Gonzalez was informed that if he joined, he could pursue exploration of a Mexico Sister City, an idea expressed by late Councilmember John J. Kennedy and Councilmember Tyron Hampton.
- He was also informed that he could serve on the Board to participate in the exploratory process.

#### Category 3: Governance & Process Requirements

- PSCC bylaws require a minimum of 10 active members to form a subcommittee.
- Subcommittees must demonstrate sustainability and capacity.
- All new Sister City proposals must follow an established vetting process before a recommendation is brought to City Council.
- These requirements are intended to ensure transparency, accountability, and longterm success.

#### **Category 4: Concerns About Procedure**

- Rene Gonzalez and Councilmember Madison have proposed accelerating or bypassing steps required in establishing a Mexico Sister City.
- Councilmember Steve Madison has voiced support for Rene Gonzalez and expediting this project; however, the process must adhere to bylaws and procedures governing PSCC and City partnerships.
- Councilmember Tyron Hampton has actively participated with PSCC to promote clarity in the relationship between PSCC and the City of Pasadena.

#### **Closing Statement**

The board supports the establishment of a Mexico Sister City and aims to achieve this goal by the end of 2025, with a long-term vision for additional partnerships. The integrity of the process remains important, as adherence to established rules maintains program credibility. The Council is encouraged to support this initiative through official procedures as practiced with other nonprofit organizations, thereby honoring previous leadership and ensuring a stable foundation.

In closing, questions are raised regarding the Council's role in nonprofit oversight and historical context within PSCC leadership. Reference is made to prior experience and challenges faced by past councilmembers. My direct number is 626-523-2152.

Good morning Mayor Gordo and City Councilmembers,

I write with deep concern about the events unfolding in our city regarding the Pasadena Sister Cities Committee (PSCC), and more specifically, the persistent and unwarranted attacks directed toward my mother, Lena Louise Kennedy, in her role as President.

PSCC has thrived under my mother's leadership. A leader should be judged by results, and Lena's record of achievement speaks for itself. Her results are undeniable and unrefuted—an objective fact that cannot be dismissed.

Honorable Mayor Gordo and Councilmembers,

I unequivocally express our collective support for the establishment of a Mexico Sister City. This initiative promises to imbue Pasadena with rich cultural, educational, and economic benefits. However, we must maintain the integrity of the process as we pursue this commendable goal.

The Pasadena Sister Cities Committee (PSCC) adheres to bylaws and procedures designed to protect our nonprofit status, safeguard the City, ensure transparency, and uphold our credibility with international partners. Allow me to present the following facts, organized in accordance with PSCC bylaws and procedures:

#### Category 1: Membership Timeline & Entry

- In October 2023, Rene Gonzalez approached then-PSCC Membership Chair Michael Warner regarding membership. Mr. Warner informed him he would need to wait until 2024.
- Mr. Gonzalez then consulted former Mayor Terry Tornek, who advised him to follow Mr. Warner's guidance.
- Subsequently, Mr. Gonzalez contacted then-Executive Board member Lena Louise Kennedy, who informed him that under PSCC bylaws, he was eligible to join immediately.
- Membership before November 2023 made Mr. Gonzalez eligible to vote in the December 2023 election, as bylaws require 30 days of membership before voting rights apply.

#### Category 2: Commitment to a Mexico Sister City

- Mr. Gonzalez was assured that if he joined, he would be supported in pursuing the exploration of a Mexico Sister City, an idea long championed by the late Councilmember John J. Kennedy and Councilmember Tyron Hampton.
- He was also assured he could serve on the Board to help navigate the exploratory process.

#### Category 3: Governance & Process Requirements

- PSCC bylaws require a minimum of 10 active members to form a subcommittee.
- Subcommittees must demonstrate sustainability and capacity.
- All new Sister City proposals must follow the established vetting process before a recommendation is brought to the City Council.
- These requirements exist to ensure transparency, accountability, and long-term success.

#### Category 4: Concerns About Procedure

- Rene Gonzalez, Martin Gordon, and Councilmember Madison have attempted to accelerate or bypass steps required in establishing a Mexico Sister City.
- Councilmember Steve Madison has voiced strong support for Mr. Gonzalez and expediting this project; however, the process cannot be driven by individual agendas. It must adhere to the bylaws and procedures that govern PSCC and City partnerships.

There are Councilmembers such as Councilmember Tyron Hampton and Rick Cole, who have been steadfast advocates for PSCC, consistently working with transparency and integrity to promote justice, fairness, and unity. Over the past two years, Councilmember Hampton has worked closely with me, as President, requesting clarification from the City Manager and City Attorney regarding the relationship between PSCC and the City of Pasadena, all while seeking to strengthen the partnership and ensure a productive and sustainable collaboration. Similarly, Councilmember Rick Cole truly fosters "One Pasadena," consistently promoting harmony and fairness, and both Councilmembers fully support and look forward to establishing a Mexico Sister City.

We fully support establishing a Mexico Sister City, and our Board has committed to realizing this objective by the end of 2025. We are on track to achieve that goal and even envision the addition of a second Mexico Sister City.

Nonetheless, maintaining the integrity of the process is equally important. Bypassing established rules for one project risks undermining the credibility of the entire Pasadena Sister Cities Committee program. I urge the Council to respect this effort by adhering to the proper procedures, as expected of all nonprofit organizations. By doing so, we honor past leaders, protect our city's credibility, and lay a foundation strong enough to last for generations. Let us move forward with unity, respect, and integrity to make the Mexico Sister Cities a reality—the right way.

In closing, I must present the following questions: Pasadena has over 300 nonprofits—when did the City Council begin usurping the leadership of these organizations, or is this a personal attack on this leadership? Dear Mayor Gordo and Members of the Council,

Today's Pasadena Now article about Councilmember Steve Madison's request for an update on the Guanajuato Sister City proposal is refreshing. It is good to see leadership publicly recognizing the promise of citizen diplomacy and the bridges it can build for Pasadena.

But with that excitement comes a serious responsibility. This Council cannot celebrate diplomacy abroad while ignoring the erosion of democratic practices at home.

When the PSCC Executive Board manipulates procedures, restricts access to information, silences voices during meetings, and withholds membership rosters that are essential to fair elections, those are not minor oversights — those are behaviors that mirror discriminatory practices under the law. In today's society, discrimination is not always explicit. It is often cloaked in procedural control, selective exclusion, retaliation against critics, and the quiet denial of equal participation.

History teaches us that complacency in the face of these behaviors allows them to harden into systemic exclusion. And once discrimination becomes embedded in governance, it takes on legal significance. These are the very patterns that agencies like the U.S. Equal Employment Opportunity Commission (EEOC) are trained to identify: disparate treatment, hostile environments, retaliation, and obstruction of fair process.

As citizen diplomats and public officials, we may not always recognize these patterns ourselves. But experts in civil rights enforcement know how to identify them clearly. And it is my sincere hope that Pasadena does not allow this situation to reach the point where federal or state oversight becomes necessary.

After you hear the report tonight, I urge this Council not to let enthusiasm distract from the hard truth: without intervention, these practices will continue unchecked. If this Council chooses not to act, it will send a devastating message — that in Pasadena, power may be abused, elections may be manipulated, voices may be silenced, and discrimination may be tolerated so long as it is dressed up as diplomacy. That is a dangerous precedent. It tells every resident, every partner city, and every young person watching that fairness is negotiable and accountability is optional. Pasadena must not allow itself to be

remembered for complacency in the face of injustice. The integrity of this City and the credibility of its global partnerships depends on your courage to confront this now.

But gratitude does not erase responsibility. The world is watching how Pasadena governs itself. Our partners abroad are watching. And our children who will inherit this City are watching. I urge you to act with fairness, with transparency, and with courage. If you do, Pasadena can demonstrate not only to its citizens but also to its global partners that we lead with integrity, value inclusion, and are willing to correct course when it matters most.

Dear Honorable Mayor and Members of the Pasadena City Council,

I am writing with deep concern regarding the conduct of Rene Gonzalez in connection with the Sister Cities Committee, specifically as it relates to Guanajuato, Mexico. It saddens me that what is intended to be a positive and unifying program—especially considering the ongoing deportations and hardships faced by members of the Latino community—has been overshadowed by behavior that is aggressive, harassing, and wholly unrepresentative of the values of the City of Pasadena.

Under California law (Cal. Penal Code § 646.9 and related civil statutes), harassment includes a knowing and willful course of conduct directed at a specific person that seriously alarms, annoys, or harasses the person, and that serves no legitimate purpose. Such conduct may consist of repeated actions, communications, or behaviors that would cause a reasonable person to suffer substantial emotional distress.

### **Specific Examples of Harassment**

Mr. Gonzalez's conduct falls squarely within this definition:

- On September 27, 2025, at Chris Holdens block party Mr. Gonzalez deliberately set up a table just feet away from Sister Cities President Kennedy's, with the clear intent of antagonizing and harassing her directly and by way of third party.
- He spent the entire day engaging in defamation, spreading false narratives about her character and leadership knowing others will repeat what he is saying and speaking negatively within earshot of her with the intent to harass and bully her.
- His actions are part of an ongoing pattern of harassing women, as evidenced by his similar treatment of School Board Member Michelle Bailey.
- It is also on public record that Mr. Gonzalez has an active order filed against him by his wife, further establishing a pattern of abusive and controlling behavior (Public Record).

Mr. Gonzalez's actions reflect classic abusive and harassing tactics, including:

- Attempting to intimidate and dominate women through proximity and presence.
- Spreading false narratives with the goal of undermining reputations.
- Using excessive and baseless communications to badger and pressure individuals into compliance.

Allowing Mr. Gonzalez to use his platform in Sister Cities while engaging in such behavior sends the wrong message and risks inciting further hostility that can result in violence. Given the political climate and the rise in

national violence, Pasadena must not condone harassment, bullying, or intimidation by those in leadership or representative roles.

It is important to emphasize that Mr. Gonzalez has a documented history of domestic violence. Restraining orders are not granted lightly; they require substantial evidence to succeed in court. Records also indicate over 500 calls for service related to family violence involving him. To embolden and give a platform to individuals who operate this way creates serious safety concerns for everyone.

The City of Pasadena has a responsibility to ensure that those representing the city, especially in international partnerships, reflect the core values of dignity, respect, and inclusion. The world is watching how we lead, and the Mexican Sister City platform provides a powerful opportunity to model love, support, and unity for people from all countries and walks of life.

I urge City Council to carefully reconsider who is allowed to represent Pasadena in this capacity. The Mayor of Guanajuato, who stands firmly against domestic violence, would be deeply displeased to learn that the Chair of Pasadena's Sister Cities Committee is actively engaged in harassing women and displaying ongoing disrespect toward them.

Pasadena must take a clear stand that harassment, abuse, and intimidation—whether verbal, emotional, or physical—will not be tolerated by anyone representing our city. I will not sit back and be complacent in what I have seen and experienced with my own ears and eyes, and after gathering further information I am concerned with the City of Pasadena's complacent tone with what's been transpiring for almost two years. It's just not acceptable and needs to be addressed.

I am writing because my Aunt Lena is under attack, and it is not acceptable. She is one of the hardest-working volunteers I know and gives selflessly to our community. Her work with Pasadena Sister Cities is truly impressive. Yet, two individuals, Rene Gonzalez and Martin Gordon, are attacking her because she refuses to be bullied into bypassing the proper process to establish a Mexico Sister City—a project we are all excited to see become a reality.

Previously, in December 2023, Michael Warner verbally attacked her simply because she won the election as President of a 75-year-old organization that had historically been led by non-Black individuals. Then, in January 2024, he escalated his attacks at a Pasadena City Council meeting, where he was given a platform to publicly criticize her. This is not acceptable. Now, nearly two years later, these attacks continue. For a long time, she, her family, and friends have remained silent—but that stops now.

I strongly urge the City Council to stop allowing individuals to come before you and attack my Aunt Lena—or any other member of our community. Please establish clear rules, processes, and protocols to prevent this type of behavior in the future. It is deeply
