APPROVE THE PUBLIC HOUSING AGENCY ADMINISTRATIVE PLAN UPDATES (Housing Dept.)

Recommendation: It is recommended that the City of Pasadena (the "City"), as Successor Agency to the Pasadena Community Development Commission, after a public hearing:

- (1) Find that the recommended action in the agenda report is exempt from the California Environmental Quality Act ("CEQA"), pursuant to State CEQA Guidelines per 15061(b)(3), the "Common Sense" exemption that CEQA only applies to projects that may have a significant effect on the environment; and
- (2) Approve certain updates to the City's Public Housing Agency Administrative Plan, as described in the agenda report.

Secretary Jomsky reported that the public hearing notice was published in the Pasadena Press on November 24, 2025 and that no correspondence was received by the City Clerk's Office for this item.

Adriana Bautista, Pasadena resident, expressed support for the City's public housing programs and provided comments on the homelessness crisis.
