I am writing to formally announce my retirement from the City of Pasadena's Arts & Culture Commission, effective January 15, 2026. With extended travel plans ahead this spring, I believe it is in the best interest of the Commission to appoint a new member who can fully engage in the work of the coming year.

It has been an honor to serve the City on the Arts & Culture Commission for the past five and a half years. I have been deeply grateful for the opportunity to contribute to Pasadena's cultural landscape and to support the important work of the Cultural Affairs Division. During my tenure—including as Commission Chair and Public Art Subcommittee Chair — I have been privileged to work alongside thoughtful colleagues and dedicated staff in advancing the City's commitment to the arts.
