**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA,
CALIFORNIA, DECLARING THE RESULTS OF THE CITY'S PRIMARY
NOMINATING MUNICIPAL ELECTION HELD ON TUESDAY, JUNE 2, 2026**

WHEREAS, a Primary Nominating Municipal Election for members of the City Council in Districts 3, 5, and 7 of the City of Pasadena was called by the City Council to be held on June 2, 2026; and

WHEREAS, the Los Angeles Registrar Recorder/County Clerk conducted said election on behalf of the City, canvassed the returns, and certified the results of said election, and those results are attached as "Exhibit A" (Certificate of the Canvass of the Election Returns) and are incorporated herein by reference; and

WHEREAS, the City Clerk has submitted the certified results of said canvass to the City Council of the City of Pasadena.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PASADENA
RESOLVES AS FOLLOWS:**

1. The following be declared to be the results of the Primary Nominating Election for members of the City Council, Districts 3, 5, and 7:

DISTRICT 3 (Full, four-year term)

Erica Margarita Muñoz	931 votes	(23.30%)
Justin L. Jones	3,065 votes	(76.70%)

DISTRICT 5 (Full, four-year term)

Jess Rivas	3,444 votes	(100%)

DISTRICT 7 (Full, four-year term)

Jason Lyon	5,184 votes	(84.31%)
Alethea O'Toole	965 votes	(15.69%)

2. That Justin L. Jones, having received a majority of the total votes cast for candidate for the office of Member of the City Council from District 3, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 3 for a full term of four years. The term of office shall begin on Monday, December 7, 2026.

3. That Jess Rivas, having received 100% of the total votes cast for candidates for the office of Member of the City Council from District 5, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 5 for a full term of four years. The term of office shall begin on Monday, December 7, 2026.

4. That Jason Lyon, having received a majority of the total votes cast for candidates for the office of Member of the City Council from District 7, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 7 for a full term of four years. The term of office shall begin on Monday, December 7, 2026.

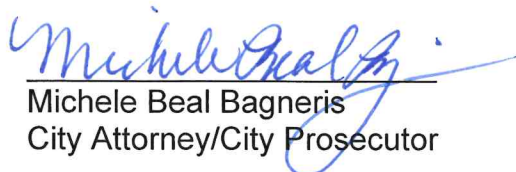
