## KEEP PASADENA'S INVESTMENTS APOLITICAL AND LOCALLY FOCUSED

For more than a year, public comment during Pasadena City Council meetings has been dominated by a coordinated campaign urging the City to adopt divestment measures barring investments tied to Israel. Week after week, speakers have pressed the Council to align Pasadena with the Boycott, Divestment, and Sanctions (BDS) movement—a national and international effort intended to isolate Israel economically and institutionally.

The Council now faces a decision that will determine whether those demands become policy. As it considers revisions to Pasadena's investment guidelines, including potential expansion of Environmental, Social, and Governance (ESG) criteria, Councilmembers should reject efforts to use those tools to single out one foreign nation—and one alone—for sanction.

At a practical level, the BDS proposal accomplishes nothing. Pasadena holds no direct investments in Israeli companies and does not meaningfully invest in firms whose limited activities in Israel would be affected by a municipal policy change. Any action would therefore be purely symbolic—an expression of political alignment, not financial stewardship.

That is precisely the problem.

Municipal investment policy is not a platform for geopolitical signaling. Its purpose is to safeguard public funds, guided by well-established principles: safety, liquidity, and return. Converting that function into a vehicle for highly partisan ideological positioning risks distorting its purpose and undermining disciplined fiscal management.

Recent Council meetings have featured rhetoric that extends far beyond policy disagreement, including repeated accusations of “genocide” and “apartheid,” as well as language many Jewish residents experience as stigmatizing. The term “Zionist,” used pejoratively, is used not as a narrow critique of policy, but weaponized as a broader denunciation of those who support Israel's existence—an overwhelming majority within the Jewish community, and many others as well.

It would be unthinkable for the Council to validate this environment by adopting a measure demonizing Israel, as activists insist.

These concerns are not abstract. Jewish institutions and individuals in Southern California, including Pasadena, have reported incidents of antisemitic harassment, vandalism, and even violence. Earlier this year, the remains of the Pasadena Jewish Temple and Center (destroyed in the Eaton fire) were defaced with anti-Zionist graffiti. Community leaders have warned that normalizing extreme rhetoric about Israel can contribute to a climate in which hostility toward Jews becomes more acceptable.

That context should give the Council pause before adopting any measure likely to be interpreted as taking sides in a deeply polarizing international conflict—and, in the process, alienating members of its own community.

The broader conflict itself is complex and contested. It followed the October 7, 2023, attack by Hamas, in which Hamas murdered approximately 1,200 Israelis and took around 250 as hostages. Israel's military response in Gaza that targeted Hamas terrorists, in the face of Hamas' promise to do it "again and again," has resulted in significant death and destruction. These events continue to generate intense global disagreement. But they are matters for national governments and international institutions—not for municipal bodies, which lack both the authority and the expertise to adjudicate them.

If modified ESG principles are to be incorporated into Pasadena's investment strategy, they must be applied consistently and tied to financial risk, long-term value, and matters within the City's proper scope of responsibility. Selectively targeting Israel—as BDS advocates demand—undermines both the integrity and the credibility of such policies. It would call into question whether Pasadena remains a welcoming place for its Jewish residents.

The Council's upcoming deliberations—expected to culminate at its May 11 meeting—offer an opportunity to reaffirm proper boundaries. After months of acrimonious Council meetings, the time has come for a clear and final determination rejecting BDS.

Pasadena faces real and pressing local challenges—fiscal, social, and infrastructural. Our City's investment policies should reflect those priorities, not serve as instruments for highly polarizing symbolic foreign policy pronouncements.

The Council has listened. Now it should act—by refusing to adopt BDS, keeping its investment policies apolitical, and focusing on its core responsibility: governing in the best interests of all Pasadena residents.

Dear Pasadena City Council Members and Mayor,

I am hoping that on May 11, as you decide on whether council will prohibit investments in weapons manufacturers, fossil fuel companies and private prisons, you do not disregard the call to prohibit investment in mass surveillance. And most importantly, that you include language about divestment from genocide, specifically naming the genocide in Palestine. We have been speaking to you for more than a year, attending every council meeting you hold to be able to engage with you on the topic. This email is not a one off, it is part of a long commitment to converse with you.

It is difficult to understand what more remains to be said about why Pasadena should divest from entities tied to war crimes and the machinery of genocide. You have heard directly from community members whose families and loved ones have been displaced, starved, imprisoned, tortured, and killed with the support of U.S. tax dollars and political backing. I have told you about my family in Palestine and still, I wonder if you are moved.

You have been told that Gaza's civilian infrastructure has been systematically destroyed: schools, hospitals, places of worship, kindergartens, pharmacies, libraries, cultural centers, music conservatories, and homes. You have heard that genocide scholars, human rights experts, and international institutions are calling Israel's actions in Gaza, a genocide.

We have asked for our lives and our grief to be treated with the same dignity and moral seriousness afforded to the Armenian community who have endured genocide. I am both Armenian and Palestinian but it seems you only acknowledge the atrocities against some of my people. Palestinians deserve being cared for in the same way!

During the council meetings, we have also pointed out how religion is weaponized politically by Israel to shield state violence from accountability and to pressure elected officials away from making principled moral decisions – exactly like MAGA here. Why can you point the finger at Trump and his administration, and not on Israel?

Do not be driven by fear. But be driven by your values and heart.

We are asking you to ensure that Pasadena is not financially complicit in the destruction and suffering inflicted on Palestinians. Other cities across the United States have already taken steps toward divestment because they recognize that neutrality in the face of mass suffering is not moral leadership. Be inspired by them, and be an inspiration for others yourself.

At this point, the question is no longer whether you have heard enough. The question is whether you are willing to act on what you already know.

Please use your position and power to do what is right. Make the choice your grandchildren will one day be proud of.

We all aspire to a world where human rights are upheld, where conflicts are resolved through dialogue, and where justice prevails. BDS, while often framed as a human rights campaign, does the opposite and is fundamentally unjust.

### **BDS is inherently discriminatory.**

It is not applied universally to nations accused of human rights violations; it disproportionately targets, delegitimizes, and singles out the world's only Jewish state.

The UN reported that Russia deliberately attacked Ukrainian civilians in the Kherson terror campaign they called a "Human Safari". The report said that this was a war crime, a crime against humanity.

Where is the BDS movements outrage?

Where are their signs, why aren't they draped in Ukrainian flags?

Why no boycott of Egypt where new evidence revealed widespread extrajudicial executions of civilians?

Why no boycott of Syria where the Alawite people were massacred in March 2025?

No boycott of China for their crimes against the Uyghurs?

When a standard is applied to one nation, and one nation alone, that is not justice—that is discrimination. And it seems to only be driven towards the one and only Jewish state. This will only lead to Judenhaas, Jewish hate.

There is a reason that the highest court in France found BDS to be illegal. They found it to be discriminatory, hateful and irresponsible in its language.

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA  
APPROVING THE PROJECT LIST FOR FISCAL YEAR 2027 FUNDED  
BY SB1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017**

**WHEREAS**, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

**WHEREAS**, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

**WHEREAS**, the City must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

**WHEREAS**, the City of Pasadena, will receive an estimated \$3,900,000 in RMRA funding in Fiscal Year 2026-27 from SB 1; and

**WHEREAS**, this is the tenth year in which the City is receiving SB 1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

**WHEREAS**, the City used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the community's priorities for transportation investment; and

**WHEREAS**, the funding from SB 1 will help the City maintain and rehabilitate streets, and add active transportation infrastructure throughout the City this year; and

1. Project Name: Annual Citywide Street Resurfacing and ADA Improvement Program  
FY 2027

Total Estimated Project Cost: \$10,850,000

FY 2027 RMRA Fund Appropriation Amount: \$3,900,000

Description: This project provides for resurfacing 31 streets throughout the City for a total of 11 centerline miles and the City’s popular walking path around the Rose Bowl Stadium (aka Rose Bowl Loop). This resurfacing project will utilize various resurfacing methods, such as full-width mill and edge grind/overlay with rubberized asphalt, a noise-reducing pavement material that consists of a regular asphalt concrete mixed with crumb rubber made from recycled tires. This sustainable paving practice diverts tires from the waste stream. In addition, rubberized asphalt pavement lasts longer, is more resistant to cracking, reduces vehicle noise, provides for better skid resistance, and retains a darker color that provides contrast to new pavement markings. For concrete streets, fiber-reinforced asphalt concrete will be used to improve cost efficiency. This approach allows roadway sections to be built up to achieve thicker cross sections, reducing the need for full roadway reconstruction.

I am writing to urge you to support and expand the ethical investment resolution that has been brought to the city council. The Legislative Policy Committee's decision to recommend the prohibition of investments in weapons manufacturers, fossil fuel companies, and private prisons is truly an important first step. In addition, after reading *The Dream Hotel* by Laila Lalami, our 2026 One City One Story selection, I would be very happy to see the resolution include prohibiting investments in companies engaged in mass surveillance. It would be one more step in protecting not only our immigrant brothers and sisters, but also fighting back against the use of such technology to menace ordinary citizens as well.

In times such as these, when false narratives abound, it's also important to speak the truth about current realities. Therefore, it would be a brave and prophetic step to include language about divestment from companies who profit from genocide, specifically naming the genocide in Palestine that our tax dollars are currently funding.
