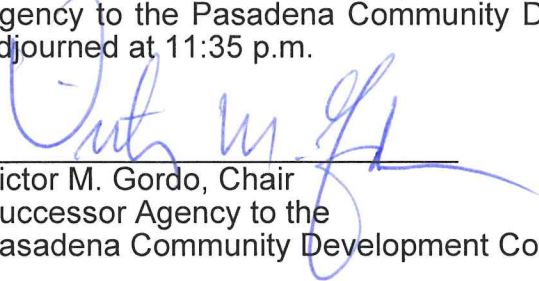
Recommendation: It is recommended that the City Council and the Successor Agency to the Pasadena Community Development Commission:

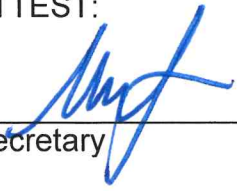
MOTION: It was moved by Member Hampton, seconded by Member Cole, to approve the Consent Calendar Items. (Motion unanimously approved) (Absent: None)
