SUBJECT: APPROVAL OF FY 2000 AGREEMENT BETWEEN THE STATE

DEPARTMENT OF HEALTH SERVICES AND THE CITY OF PASADENA IN THE AMOUNT OF \$7.691 FOR A CHLAMYDIA AWARENESS AND

PREVENTION PROJECT

RECOMMENDATION:

It is recommended that the City Council:

- 1. Authorize the City Manager to execute an FY 2000 Agreement between the State Department of Health Services and the City of Pasadena in the amount of \$7,691 for the period January 1, 2000 through June 30, 2000; and,
- 2. Approve a journal voucher increasing estimated revenues and appropriations in the Disease Prevention and Control Division budget account # 563100 by \$7,691 from \$1,470.414 to \$1,478,105.

BACKGROUND:

More than 68,700 cases of the sexually transmitted disease chlamydia (CT) were reported in California in 1997. Experts estimate that due to under-reporting and undiagnosed infections, closer to 300,000 women and their partners are infected annually. The purpose of the funding for this project is to promote CT awareness and enhance use of effective prevention strategies by the Health Department and other local providers.

In Pasadena, the funding will cover 5% of an existing Senior Registered Nurse to design and implement local interventions and collaborative efforts, which may include: forums, discussion sessions, surveys, targeted awareness and prevention activities, in-service training for staff and local providers. Staff will also develop a detailed work plan, which, if approved by the State will be incorporated into the state's FY2001 budget. Future grant levels for this program are contingent upon State funding availability. Current year funding will also be used to purchase educational and outreach materials and other supplies.

FISCAL IMPACT:

Revenue for this program increases the Public Health Department's Disease Prevention and Control Division FY 2000 budget account # 563100 by \$7,691 from \$1,470,414 to \$1,478,105.
