AN ORDINANCE OF THE CITY OF PASADENA GRANTING NON-EXCLUSIVE FRANCHISES FOR SOLID WASTE COLLECTION TO 48 APPLICANTS.

WHEREAS, on March 15, 1999, the City Council of the City of Pasadena considered applications for non-exclusive solid waste collection franchises and, after determining that said applications appeared to comply with Chapter 8.61 of the Pasadena Municipal Code, adopted Resolution No. 7722 declaring the intention to consider the granting of said non-exclusive franchises; and

WHEREAS, said Resolution was duly published on April 15, 1999, and;

WHEREAS, a duly-noticed public hearing pursuant to said Resolution was held on April 26, 1999 on the applications; and

WHEREAS, after reviewing each application, and after public hearing, it was determined that specific applicants comply with Chapter 8.61 of the Pasadena Municipal Code.

NOW THEREFORE, the People of the City of Pasadena ordain as follows:


