The video of Mr. McClain's shooting and the efforts to contain the protestors after the shooting only reinforce my belief that there are too many weapons on the streets of Pasadena, and most of those weapons belong to the PPPD.. The Pasadena Police Department is overly militarized.

While I support the proposal to appoint an independent auditor to oversee cases of police abuse, bias and training, the auditor's responsibilities must not stop there. He or she must have subpoena power to demand a complete inventory of the weapons and surveillance equipment held by the PPD. This investigation must start with a request for an inventory of all the military-grade weapons donated to the PPD by the federal government. Across the country, these inventories have been notoriously lax. If we are sincerely interested in civilian oversight, the auditor must also look into the military grade weapons the PPD has at its disposal, ask for justification on their use, and know what happens when they are decommissioned or unaccounted for.
