The city council has a great opportunity to increase democracy and accountability in the city by supporting Vice-Mayor Hampton's proposal for a charter amendment to implement a police commission and independent auditor. To ensure public accountability and be in-line with other local police commissions our city needs to ensure that subpoena power is guaranteed.
